**Purpose**

To seek Council approval to proclaim June 7 – 16, 2019 as Pride Week, to raise the Rainbow flag and Transgender Pride flag at Vaughan City Hall on a date during Pride Week, and to post the proclamation on the City's website.

**Report Highlights**

- Respond to the request received from York Pride Fest, received on May 7, 2019.
- Proclamation and flag raising requested in the period of June 7 – 16, 2019.

**Recommendations**

1. That June 7 – 16, 2019 be proclaimed as Pride Week;
2. That the Rainbow flag and Transgender Pride flag are raised at Vaughan City Hall on a date between June 7 – 16, 2019 to be determined, with the flags remaining raised for the balance of Pride Week; and
3. That the proclamation be posted on the City's website.

**Background**

Correspondence was received from York Pride Fest on May 7, 2019 requesting a proclamation and flag raising.

Council has previously granted this request.

### **Analysis and Options**

The proclamation and flag raising request meets the requirements of the City's Proclamation Policy and Flag Raising/Half Masting Policy, as follows:

"That upon request, the City of Vaughan issues Proclamations for events, campaigns, or other similar matters: If the event, campaign or declaration is directly related to matters over which the City has jurisdictions or the City directly sponsors the event, campaign, or other matter", and,

"The City Clerk be delegated authority to administer the Flag Raising/Half Masting Policy".

A proclamation and flag raising would be a celebration of diversity, inclusivity and equality.

### **Financial Impact**

There is no expected financial impact with respect to this request.

### **Broader Regional Impacts/Considerations**

For almost two decades, York Region's Pride Week has been recognized by the Regional Municipality of York and proclaimed by many of York Region's municipalities.

### **Conclusion**

Staff is recommending that June 7 – 16, 2019 is proclaimed as Pride Week, to raise the Rainbow flag and Transgender Pride flag at Vaughan City Hall on a date during Pride Week, and to post the proclamation on the City's website.

# ***BY-LAW***

## **BY-LAW NUMBER 075-2019**

**A By-law of the Corporation of the City of Vaughan to amend *Parking By-law 064-2019* with respect to the fine schedule and other minor technical amendments.**

**WHEREAS** section 8(1) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that the powers of a municipality shall be interpreted broadly as to confer broad authority on a municipality to (a) enable it to govern its affairs as it considers appropriate, and (b) enhance its ability to respond to municipal issues;

**AND WHEREAS** section 11(3) and 11(8) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provide for lower-tier municipalities to pass by-laws respecting matters pertaining to highways, including parking and traffic on highways, and parking, except on highways;

**AND WHEREAS** section 391(1) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides for a municipality to impose fees or charges on persons for services or activities it provides and for the use of its property;

**AND WHEREAS** the Council of the Corporation of the City of Vaughan deems the regulation of parking necessary to ensure the safety of drivers and pedestrians, the effective flow of traffic, and the maintenance of community standards;

**NOW THEREFORE** the Council of the Corporation of the City of Vaughan enacts this By-law to regulate parking of motor vehicles within the boundaries of the City of Vaughan, as follows:

1. Amend Parking By-law 064-2019, Section 7.0(5) to state, "If the signs under 7.0(4) are not erected within ten (10) business days of the delivery of the notice from the *City*, the *City* may enter the lands in question and erect the required signs at the expense of the *Owner*, which may be recovered by action in like manner as municipal taxes;".
2. Amend Parking By-law 064-2019, Subsection 5.0(11)(h) to state, "on the inside or outside curve portion of an angle bend from the beginning of the curve to the end of the curve;".

3. Replace the Table in Schedule 10 – Offences and Corresponding Administrative Monetary Penalties with the following:
