Whereas, Terry Fox is one of Canada's most beloved national heroes, whose courage, determination, and selflessness in his Marathon of Hope inspired generations of Canadians and raised millions of dollars for cancer research; and

Whereas, Terry Fox's legacy embodies the best of Canadian values, including perseverance, generosity, and a deep commitment to making a difference in the lives of others; and

Whereas, Vaughan, as a proud Canadian municipality, has opportunities to further honour Terry Fox's memory, thereby ensuring that his story continues to inspire future generations; and

Whereas, recent tariff threats and trade disputes with the United States have reminded Canadians of the importance of national pride, unity, and the celebration of Canadian heroes who transcend political and economic tensions; and

Whereas, patriotism and the recognition of Canadian symbols and figures strengthen our national identity and foster a sense of pride among our residents; and

Whereas, renaming the Canada Drive-America Avenue Bridge to the Terry Fox Bridge would send a meaningful and positive message about the values that Vaughan and Canada stand for in the face of American threats; and Whereas, the renaming of a street should take into account the views and preferences of the residents directly affected by such a change.

It is therefore recommended:

- Mayor Steven Del Duca, on behalf of Vaughan City Council, send a letter to the Minister of Transportation for Ontario formally requesting that the Canada Drive-America Avenue Bridge be renamed the Terry Fox Bridge in honour of Terry Fox's legacy; and
- 2. Vaughan City Council direct staff to survey the residents of America Avenue to gather their opinions on a potential renaming of the street in honour of Terry Fox, with the findings to be reported back to Council for consideration.

 - Design and construct the required improvements to the storm water infrastructure that was previously existing on Memorial Hill Drive that conveyed the drainage from the existing woodlot to Wallace Street;
 - Pay applicable agreement fees and others pursuant to the City Fees and Charges By-law as amended and post necessary letters of credit;
 - c. Prepare and register, at their expense, a reference plan detailing the portion of the lands to be transferred to the City and easements that will be in favour of the City for access and maintenance. The City will register the legal transfer documents at the Owner's

- expense. A draft reference plan shall be provided to the City for review prior to depositing;
- d. Enter into an agreement with the City to remove all existing easements in favour of the City that are no longer required;
- e. Provide consent from the owner of the adjacent property, also known as 66 Wallace Street, giving permission to enter and construct within the lands a new access way along Wallace Street and re-grade the existing lot to permit the construction of the proposed single detached dwelling;
- f. Address all of Development Engineering Departments engineering comments related to the proposed site plan, and demonstrate a design that meets the City of Vaughan's Engineering Design Criteria Standards, to the satisfaction of the City;
- g. Provide a certification from Sola Engineering Inc. that a general review of the final design and specifications verifies that the Geotechnical Investigation report has been properly interpreted and implemented to the satisfaction of the City; and
- h. Provide all of the necessary clearances and reports to the satisfaction of the Development Engineering Department to support all of the exceptions to the City of Vaughan's Engineering Design Criteria Standards.
- i. For all parks, open spaces, landscape buffers, and storm water management pond block(s) in the Development that are being conveyed to the City, submit a limited Phase Two Environmental Site Assessment (ESA) report in accordance or generally meeting the intent of Ontario Regulation (O. Reg.) 153/04 (as amended) assessing the fill in the conveyance block(s) for applicable contaminants of concern. The sampling and analysis plan prepared as part of the Phase Two ESA shall be developed in consultation with the City. The implementation of the sampling and analysis plan shall be completed to the satisfaction of the City and shall only be undertaken following certification of rough grading but prior to placement of topsoil placement. Reliance on the ESA report(s) from the Owner's environmental consultant shall be provided to the City.

- j. If remediation of any portions of the conveyance block(s) is required in order to meet the applicable Standards set out in the Ministry of the Environment, Conservation, and Parks ('MECP') document "Soil, Ground Water and Sediment Standards for Use under Part XV.1 of the Environmental Protection Act" (as amended), submit a complete copy of Record(s) of Site Condition (RSCs) filed on the Environmental Site Registry including the acknowledgement letter from the MECP, covering the entire conveyance block(s) following remediation.

 - b) If deemed necessary by the City, the Owner shall submit a final/revised Draft Plan to reflect any changes as a result of the review/assessment of above conditions, including any changes to the proposed lotting fabric and/or extent of the City park, storm water management ('SWM') blocks, and/or Open Space Blocks.

3. 8811 HUNTINGTON ROAD – DE-LISTING AND COMMEMORATION OF THE HENRY BURTON HOUSE
