I just wanted to share with Council again our proposed submission on this project, which included a skiing component to be located on the NORTH side of the old Vaughan Landfill site (less direct sunlight there to melt the snow) and Mount St Louis support for the concept. We would love to see this vision materialize in some way. We think it would be great for Maple. I also wanted to remind Council, our group Ludus, proposed to build this facility for the City at no cost to the taxpayer through a Public Private Partnership.
