ACCIDENTAL WATER LEAK ADJUSTMENT POLICY

Recommendation

That the Recommendation and staff report for Accidental Water Leak Adjustment be amended as follows:

 - 1.1) “THAT consideration for an adjustment for an accidental water leak that occurred between December 1, 2018 through until the effective date of the Accidental Water Leak Adjustment policy BE APPROVED subject to conditions of the policy.”

Background

Council requested through motion that leak forgiveness consideration be given to any resident, not-for-profit or tenant retroactively since the beginning of this term of Council. The draft policy is forward looking and as such reviewing historical leaks would not be considered. However, a one-time catch up period will allow staff to review historical applications on a case-by-case basis and take into account the requirement of the policy especially the proof of repair requirement.
