I noticed yesterday as I walked by a (very small) posted sign at 4020 Major Mackenzie Drive W. about addition of four portables on the YRDSB property named Tommy Douglas Secondary School.

I am writing **to object** to this request. The school, sports fields and adjacent parks have already brought a great deal of traffic and youth parking and 'hanging out' with drugs and sex after dark.

There is no private security on the grounds, nor does YRP have ability to attend to police the ongoing problems around the school currently when called.

Installing PORTABLES will only give more places to go hang-out, get high & have sex in the night and on the weekends. Our community is not looking for Portables on our school properties.

I am opposing the adjustment/request and would like to be kept in the loop about the proceedings.

I wonder why residents living so close to the school and whose backyards are next to property are not receiving letter from City of Vaughan about this request. The minute size of the sign that is in front of school is not one that any car could see from the street. I feel that more public notice is required for the community to have a say about this large change to our area, especially one that is diminishing a new area.
