<b>Applicant Justification for Variances:</b> <small>*As provided by Applicant in Application Form</small>	The entrance to the second dwelling is required to be accessible from the street by an unobstructed hard landscape surface walkway measuring a min of 1.2 m in width. In addition to that, the hard landscape is permitted up to 0.60 m from the lot line. The total setback required to comply with both requirements is 1.8 m. The existing setback is 1.2m, leaving no space for the soft scape strip of 0.6m. Current interlocking adjoins with the neighbours walkway, and the owner wishes to keep it as is to omit any disagreement about cutting the walkway and causing a disturbance. The interlocking drains water away from the property, and there has not been any concern with standing water. It was built before 2007, and currently. Therefore, the owner requests permission to use the existing walkway as it has been functional since built.





City of Vaughan Official Plan 2010 ('VOP 2010'): "Low-Rise Residential".

**Comments:**

The Owner is requesting permission to permit a Secondary Suite in the basement of a single detached dwelling with the above noted variances.

The Development Planning Department has no objection to Variances 1 and 3. By-laws 1-88 and 001-2021 both exclude basements from the total gross floor area ('GFA') calculation. The By-laws define the dwelling's GFA as 210.81 m<sup>2</sup>, which only takes into account the main and second levels. With the basement included, the total habitable space within the single detached dwelling rises to 334.86 m<sup>2</sup>. The Secondary Suite as per the By-laws would be 59% of the size of the main and second levels, but comprise 124.05 m<sup>2</sup> or approximately 37% of the dwelling's total habitable space. Development Planning recognizes that the variances are triggered due to the way in which the By-laws require the GFA to be calculated. If the GFA included the basement level, the Secondary Suite would comply with the area requirements.

The Development Planning Department has no objection to Variance 2 as the relief for the proposed hard landscape walkway is confined to the south interior side yard. The walkway facilitates access between the front yard and the Secondary Suite entrance along with a side entrance to the main dwelling. The walkway also facilitates access between the front and rear yards. The walkway will consist of permeable pavers, which the Development Engineering Department has reviewed and is satisfied that drainage along the side yard will be maintained.

Accordingly, the Development Planning Department can support the required variances and is of the opinion that the proposal is minor in nature, maintains the general intent and purpose of the Official Plan and Zoning By-law, and is desirable for the appropriate development of the land.
