





- 1) The approval of the requested reduction in landscaping variance will not create issues with assumption of the subdivision; and
- 2) The approval of the requested reduction in landscaping variance will not cause delay in release of securities by the City to the Developer; and
- 3) The approval of the requested reduction in landscaping variance will not cause the developer and /or builder to have issues associated with final grading and landscaping approvals.

If the City would please confirm these items prior to approval it would be appreciated.

Should the City not confirm the above for the variance related to landscaping be approved and any of the above noted issues arise, the Developer will not be held responsible for remedying the issue as the City has accepted and approved the change.
