### BY-LAW

#### **BY-LAW NUMBER 169-2022**

A By-law to amend City of Vaughan By-law 001-2021.

WHEREAS the matters herein set out are in conformity with the Official Plan of the Vaughan Planning Area, which is approved and in force at this time;

**AND WHEREAS** there has been no amendment to the Vaughan Official Plan adopted by Council but not approved at this time, with which the matters herein set out are not in conformity;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- 1. That City of Vaughan By-law Number 001-2021, as amended, be and it is hereby further amended by:
  - a) Deleting the reference in Schedule A, save and except Maps 18, 19, 20, 39, 40, 60 and 80 in Schedule A, where it is indicated on the legend that "These lands shall not be subject to Zoning By-law 2021-01" and replacing it with the following:
    - "These lands shall not be subject to Zoning By-law 001-2021."
  - b) Deleting Subsection 14.2 and replacing it with the following:
    - "2. The requirements of this By-law shall not apply to lands subject to a Minister's Zoning Order, a Minister's Order, or Lands Subject to Stayed Appeals by the Minister of Urban Affairs and Housing as shown on Schedule A where it is indicated on the legend that "These lands shall not be subject to Zoning By-law 001-2021."
  - c) Deleting Subsection 15.1 and replacing it with the following:
    - "15.1 From the date of the coming into force of this By-law, Zoning By-law
      1-88, as amended, is repealed in its entirety, including all sections,
      schedules, and amendments that apply to all lands subject to Zoning
      By-law 1-88, as amended, save and except for lands shown on

Schedule A where it is indicated on the legend that "These lands

shall not be subject to Zoning By-law 001-2021", for matters of

Transition as prescribed within Subsection 1.6 of this By-law, and to

the extent this By-law remains under appeal at the Ontario Land

Tribunal."

d) Deleting Schedule B-4 and substituting therefor Schedule B-4 attached

hereto as Schedule '1'.

e) Deleting Maps 4, 5, 50, 51, 54, 55, 110, 128, 200, 201, 202, 203, 204, 221,

222, 223, 224, 225, 229, 230, 242, 243, 244, 245, 249, 250 and 251 in

Schedule A and substituting therefore Maps 4, 5, 50, 51, 54, 55, 110, 128,

200, 201, 202, 203, 204, 221, 222, 223, 224, 225, 229, 230, 242, 243, 244,

245, 249, 250 and 251 attached hereto as Schedules '2', '3', '4', '5', '6', '7',

'8', '9', '10', '11', '12', '13', '14', '15', '16', '17', '18', '19', '20', '21', '22', '23',

'24', '25', '26', '27' and '28'.

hereby form part of this By-law.

#### SUMMARY TO BY-LAW 169-2022

The lands subject to this By-law include all lands within the City of Vaughan, in the Regional Municipality of York, with the exception of lands in the vicinity of Yonge Street and Steeles Avenue, where By-law 001-2021 is applicable.

The purpose of this By-law is to ensure that lands subject to a Minister's Zoning Order, a Minister's Order, or Lands Subject to Stayed Appeals by the Minister of Urban Affairs and Housing issued in the context of By-law 1-88, as amended, are excluded from the application of By-law 001-2021.
