#### <u>Purpose</u>

To enact a by-law to stop up and close the portions of the unopened road allowances between Lots 10 and 11 Concession 8 (Langstaff Road), and Concessions 7 and 8 (Kipling Avenue).

## Report Highlights

- On April 26, 2022, Council approved the disposition of the unopened road allowances between Lots 10 and 11 Concession 8 (Langstaff Road), and Concessions 7 and 8 (Kipling Avenue) and directed the Clerk to commence road closure procedures.
- On May 20, 2022, the Clerk caused notice(s) of the proposed by-law to stop up and close the unopened road allowances between Lots 10 and 11 Concession 8 (Langstaff Road), and Concessions 7 and 8 (Kipling Avenue).

# Recommendations

- 1. That any deputations on the matter be received; and
- 2. That a by-law be enacted to stop up and close the portions of the unopened road allowances between Lots 10 and 11 Concession 8 (Langstaff Road), and Concessions 7 and 8 (Kipling Avenue).

#### **Background**

On April 12, 2022, City staff determined that the portions of the unopened road allowances between Lots 10 and 11 Concession 8 (Langstaff Road), and Concessions 7 and 8 (Kipling Avenue) should also be stopped up and closed as public highways as they are considered natural areas and will be used as public open space areas in the future.

On May 20, 2022, the notice of road closure was advertised for two (2) consecutive weeks on the Disruptions and Closures page of the City's website and the appropriate agencies have been notified of the proposed by-law.

#### **Previous Reports/Authority**

Item 2, Report No. 20, of the Committee of the Whole (Closed Session), which was adopted without amendment by the Council of the City of Vaughan on April 26, 2022.

#### **Analysis and Options**

Given the results of Council's deliberations at its meeting of April 26, 2022 and Council's directions to commence road closures procedures, staff recommend that a by-law be enacted to stop up and close the portions of the unopened road allowances between Lots 10 and 11 Concession 8 (Langstaff Road), and Concessions 7 and 8 (Kipling Avenue) in accordance with the *Municipal Act, 2001*. The proposed road closing is not required for the City's municipal purposes.
