<u>Purpose</u>

To seek Council's endorsement of the Order of Vaughan Selection Committee's list of recipients for the 2022 Order of Vaughan.

Report Highlights

- The Order of Vaughan was initiated in 2016 as part of the City of Vaughan's 25th Anniversary Celebration, recognizing 25 years as a city.
- A total of 17 nominations were received for 2022.
- Recipients will be recognized at a ceremony at Vaughan City Hall on Thursday, November 3, 2022.

Recommendations

- 1. That Council endorse the individuals recommended by the Order of Vaughan Selection Committee and set out in Confidential Attachment 1 to this report, as the 2022 recipients of the Order of Vaughan; and
- 2. That the names of the individual recipients be made public following notification by the Mayor.

Background

The Order of Vaughan award program was established by Council's adoption of Item No. 16 of Report No. 40 of the Committee of the Whole on November 17, 2015, and of Item No. 9 of Report No. 12 of Committee of the Whole on March 22, 2016.

The Order of Vaughan is presented as Vaughan's highest civic honour. The Order of Vaughan is granted to a maximum of ten individuals annually, except in the first year (2016) when 25 individuals were recognized for their contributions to the city over its first 25 years.

Recipients will become Members of the Order of Vaughan and will be permitted to indicate such membership by wearing a pin presented at a public ceremony. The initiative is modelled after the Order of Canada and Order of Ontario, and similar programs have been established by cities such as Ottawa and Montreal.

Arts and Entertainment Business Science and Technology Environment Media and Communications Philanthropy Not-For-Profit Spiritual Athletics Public Service Equity and Diversity Health and Wellness Education Accessibility

In all, nomination packages for 19 individuals were reviewed by the Order of Vaughan Selection Committee.

Financial Impact

Funding for the 2022 Order of Vaughan ceremony is captured in the budget for the Office of the City Clerk.
