*BY-LAW*

**BY-LAW NUMBER 239-2022**

**A By-law of The Corporation of the City of Vaughan to amend Fees and Charges By-law 158-2021, as amended.**

**WHEREAS** subsection 5(3) of the *Municipal Act, 2001, S.O. 2001, c. 25 (“Municipal Act”)*, as amended, provides that a municipal power shall be exercised by by-law;

**AND WHEREAS** section 391(1) of the *Municipal Act* provides that a municipality may pass by-laws imposing fees or charges on persons for services or activities provided or done by or on behalf of it;

**AND WHEREAS** subsection 391(3) authorizes a municipality to include in a fee or charge costs incurred by the municipality related to administration, enforcement and the establishment, acquisition and replacement of capital assets;

**AND WHEREAS** Council has determined that it is desirable to make amendments to By-law 158-2021, as amended, for housekeeping purposes and to introduce fees for lounges and night clubs and for snowplow contractors;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. That Fees and Charges By-law 158-2021, as amended, be further amended by replacing the words “Parking Permit Transaction Fee (all parking permits)” with “Parking Permit Transaction Fee (all online parking permit payments)” in Schedule I.
2. That Fees and Charges By-law 158-2021, as amended, be further amended by adding the following line to Schedule I:

Penalty notice transaction fee (all online penalty notice payments)	\$2.00	\$2.00	E

3. That Fees and Charges By-law 158-2021, as amended, be further amended by repealing the following rows from Schedule N:

Accessible taxi license re-inspection fee
Driving School Licensing Re-inspection
Limousine licensing re-inspection fee
PTC Vehicle licensing re-inspection fee
Refreshment vehicle licensing re-inspection fee
Taxi licensing re-inspection fee
Tow Truck Re-inspection Fee

4. That Fees and Charges By-law 158-2021, as amended, be further amended by adding the words “(applies to all vehicular licences)” after the words “Vehicle Re-Inspection Fee” in Schedule N.
5. That Fees and Charges By-law 158-2021, as amended, be further amended by replacing the words “Charitable Clothing Drop Boxes” with the words “Clothing Donation Drop Boxes” in Schedule N.
6. That Fees and Charges By-law 158-2021, as amended, be further amended by replacing the words “Refreshment Vehicles Owner Class A/B” to “Refreshment Vehicles Owner Type 1/2” in Schedule N.
7. That Fees and Charges By-law 158-2021, as amended, be further amended by replacing the words “Refreshment Vehicles Owner Class C” to “Refreshment Vehicles Owner Type 3” in Schedule N.
8. That Fees and Charges By-law 158-2021, as amended, be further amended by repealing the fees for Fire Works Vendors from Schedule N and replacing them with the following:

9. That Fees and Charges By-law 158-2021, as amended, be further amended by adding the following fee, immediately after the fee for Eating Establishments to Schedule N:

10. That Fees and Charges By-law 158-2021, as amended, be further amended by repealing the fees for Fence Installer, Paver and Pool Installer from Schedule N and replacing it with the following fees:

<b>Paver</b>	\$467.00	\$219.00	\$502.00	\$221.00	E
<b>Pool installer</b>	\$467.00	\$219.00	\$502.00	\$221.00	E

11. That Fees and Charges By-law 158-2021, as amended, be further amended by adding the following fees to Schedule N in alphabetical order:

<b>Snowplow Contractor</b>	\$467.00	\$219.00	\$502.00	\$221.00	E
<b>Snowplow Vehicle licensing placard fee (per card)</b>	\$7.00	\$7.00	\$8.00	\$8.00	E
