**Purpose**

Staff are providing Committee with a detailed summary of grant applications submitted by the City in 2022 and a comprehensive summary of the revenue generated by successfully awarded grants.

## **Report Highlights**

- In 2018, the City's grant application process was centralized in Economic Development, under the City Manager's portfolio. Following the council-approved reorganization in 2021, the function continues within Economic Development in the Office of Communications and Economic Development. This has allowed staff to leverage a broader public affairs and economic development team to drive greater outcomes.
- Immediately following the centralization of the grant application process in 2018, the volume of grant applications significantly increased. Subsequently, the volume of successfully awarded grants has increased.
- Total grant submissions more than doubled from 15 applications in 2017 (prior to the function being moved into Economic Development) to 36 applications in 2022.
- In 2022, 20 grants were successfully awarded, representing a combined value of \$8,589,880. There are currently 12 grants pending decision, valued at \$16,569,270.
- Grants secure non-taxation revenue to deliver city infrastructure, programs, and services. Since the COVID-19 pandemic, grant activity increased with support from all levels of government.

## **Background**

***Grant support is provided across the corporation by the Strategic Economic Initiatives Unit in Economic Development.***

To establish economic magnets in the City of Vaughan that will advance opportunities and attract new investments, the Strategic Economic Initiatives (SEI) business unit within the Office of Communications and Economic Development (OCED) focuses on Smart Cities, Public Art, Strategic Projects like the Vaughan Healthcare Centre Precinct, and Revenue-generation through advertising, sponsorship and grants.

In 2018, grant submission activity throughout the City of Vaughan was consolidated in the Economic Development department (now within OCED) to develop a comprehensive and consistent process to assist departments in identifying potential grants, submitting applications and monitoring/administering the process. Before this, departments prepared submissions in isolation. This resulted in inconsistent submissions, fewer successful applications and missed opportunities. The new process

created a policy to guide and refresh the grant process by centralizing submission development and establishing a point of contact to assist staff.

***Grants secure non-taxation revenue to deliver critical city infrastructure, programs and services.***

To put the contribution grants can make to the City's finances in perspective, \$2M in alternative revenue represents approximately 1% of the property tax base. Now more than ever, it is critical for the City to remain focused on diversifying its revenue streams.

## **Analysis and Options**

***Since 2017, the City of Vaughan has increased the number of annual grant application submissions.***

According to the council-approved Grant Funding Policy, staff are continually encouraged to find ways to generate non-taxation revenue to support Council approved initiatives. The policy process has enabled an increase in the number of applications submitted year-over-year for grants from federal and provincial governments and private funding bodies. As a result, the number of successful applications has significantly increased. Grants from governments and various funding bodies provide non-taxation revenue for city infrastructure, programs and services.

\*The global COVID-19 pandemic forced governments to shift from offering grants to providing emergency business and healthcare aid. As a result, the City submitted fewer grant applications.

***Since 2017, the City of Vaughan has seen a consistent increase in the number of awarded grant applications.***

\*Although the number of awarded grants was lower than average in 2020 during the height of the COVID-19 pandemic, the success rate increased to 94%, with 16 awarded projects out of 17 applications.

**Capital investment remains steady, with three major programs currently offsetting \$6,576,253 from the property tax base.**

#### 1. Government of Canada

The City of Vaughan was awarded \$2,981,250 for the following projects:

- a) Pierre Berton Heritage Centre Parking Lot Revitalization - \$375,000
- b) Playground resurfacing and Sensory Gardens - \$375,000
- c) Woodbridge Library Entrance Renovation - \$731,250
- d) Keele Street Multi-Use Pathway - \$750,000
- e) Woodbridge Avenue Streetscape - \$750,000

#### 2. Strategic Priorities Infrastructure Fund (SPIF)

In response to outstanding funds in the Invest in Community Infrastructure Program (ICIP), the 2021 Ontario Budget included approximately \$200 million to provide infrastructure funding to more significant, strategic projects and sports facilities through the newly established Strategic Priorities Infrastructure Fund.

The City of Vaughan was awarded \$3,584,003 for the following project:

- a) Doctors Mclean Park Redevelopment and Riverwalk Trail

The project proposed is for the redevelopment and enhancement of Doctors Mclean District Park, located in Woodbridge's growth centre, that includes new park features and an expansion and rehabilitation of the current trail system (Riverwalk) to the north. The scope consists of designing and revitalizing existing parkland and open space facilities, including shade shelters and picnic areas; walkways, trails and pedestrian bridge crossings; site furnishings and interpretive signage; and habitat enhancements, including pollinator gardens.

### 3. The Atmospheric Fund (TAF)

The Atmospheric Fund is a not-for-profit organization that invests in low-carbon solutions that benefit the Greater Toronto and Hamilton Area (GTHA) and help scale them up for broad implementation through financing, grants, and programs. The EV Station Fund supports the installation of charging stations across the GTHA through technical and financial support, including up to a 50% contribution towards the installation costs.

The City of Vaughan was awarded \$11,000 for the following project:

a) Pierre Berton Heritage Centre EV charging infrastructure

Funding is for installing one EV charging station at the Pierre Berton Heritage Centre in Kleinburg. The EV charging station has connections that can charge two vehicles simultaneously. The program also provides an additional rebate for advisory support to assist with continued program delivery.

***Operational grant funding has increased, with 17 grants awarded for various programs and initiatives, significantly offsetting the property tax base by \$2,013,627.***

<b>Seniors Community Grant Program</b>	Grants Ontario	\$4,598	VPL applied for the Memory Lab program expansion which would allow VPL to upgrade the existing Memory Lab at Woodbridge Library and expand the service to additional locations. Memory Labs provide opportunities for older adults to learn new technologies by digitizing their old photos, slides, videos, scrapbooks and more.
<b>Small Business Enterprise Centre Funding</b>	Ministry of Economic Development, Job Creation and Trade	\$323,525	Staff have been notified of the Province's commitment to maintaining funding levels as consistent with the currently existing agreement term of April 1, 2019 - March 31, 2022. This commitment will continue through a two-year plus one-year extension Transfer Payment



			Agreement (TPA) (April 1, 2022 – March 31, 2024, March 31, 2025, if the one-year extension is applied) at the current budgeted allocation of \$323,525 per year.
<b>Streamline Development Approval Fund</b>	Ministry of Municipal Affairs and Housing	\$1,000,000	Through this fund, one million dollars was allocated to the City of Vaughan based on the need to streamline the development approval process.
<b>TD Greenspace</b>	TD Bank	\$25,000	Funding to plant trees and shrubs to create a pollinator garden at York Hill District Park in the proposed environmental learning zone will also cover the design and construction of a bio-retention facility in the same location.
<b>Young Canada Works</b>	Canadian Library & Archives	\$7,685	Summer Children's Services Assistants to support Summer Reading initiatives.

## **Financial Impact**

A total of \$8,589,880 in grant funding was awarded in 2022. There are another 12 applications pending response, valued at \$16,569,270.

## **Conclusion**

Grants secure non-taxation revenue to deliver city infrastructure, programs, and services. The volume of grant applications submitted by the city of Vaughan has significantly increased since 2017. Subsequently, the number of successful grants has also increased. This result is directly correlated to the centralization of the grant application process in 2018.

In 2022, the City was successfully awarded 20 grants, representing a combined value of \$8,589,880. There are currently 12 grants pending, valued at \$16,569,270.

Diversifying revenue sources is critical as there is increased uncertainty attributable to rising inflation, a looming recession and the ongoing impacts of the COVID-19 pandemic. Garnering support from funding partners – corporations, government

agencies, or other private institutions – is a crucial piece of the revenue puzzle.
