7. YONGE NORTH SUBWAY EXTENSION – ROUTE REFINEMENT UPDATE

Whereas, the Council of the City of Vaughan has been and continues to be supportive of the efforts by the Province to move the YNSE project forward;

Whereas, the Yonge North Subway Extension (YNSE) is a leading transportation priority for the City of Vaughan and York Region;

Whereas, it has been identified that two neighbourhood stations (Clark and Royal Orchard stations), providing important transportation connections for the City of Vaughan and neighbouring municipalities, will be implemented as part of the initial implementation of the YNSE;

Whereas, the YNSE has been identified as a critical infrastructure investment with the current York Region and City of Vaughan Transportation Master Plans;

Whereas an investment of this magnitude in fundamental transportation infrastructure needs to be recognized for its very long term positive impact;

Whereas, the implementation of the project continues and major milestones are expected to be achieved in 2022; and

Whereas, the City of Vaughan, at the Council meeting of April 20, 2021 and at the Council meeting of June 22, 2021, adopted resolutions on the Yonge North Subway Extension to support a Yonge Street alignment as the logical and best long term route for the Yonge North Subway Extension.

Whereas, all municipalities in Ontario manage their development planning process under a comprehensive and detailed set of Provincial Acts and policies; and

Whereas, the process used to come to a decision on a planning application is transparent and provides a variety of opportunities for all interested parties in the community to have a voice in the outcome, and

Whereas, Municipalities across this province collectively spend millions of dollars of taxpayer money and municipal resources developing Official Plans that meet Provincial planning policy; and

Whereas, an Official Plan is developed through extensive public consultation to ensure that future planning and development will meet the specific needs of (our) community; and

Whereas, our Official Plan includes zoning provisions that encourage development of the widest variety of attainable and affordable housing in our community; and

Whereas, it is within the legislative purview of a municipal council to approve Official Plan amendments or Zoning By-law changes that better the community or fit within the vision of the Vaughan Official Plan; and

Whereas, it is also within the legislative purview of municipal council to deny Official Plan amendments or Zoning By-law changes that do not better the community or do not fit within the vision of the Vaughan Official Plan; and

Whereas, municipal planning decisions may be appealed to the Ontario Land Tribunal (OLT; formerly the Ontario Municipal Board or "OMB"), an unelected, appointed body that is not accountable to the residents of the City of Vaughan; and

Whereas, the OLT has the authority to make a final decision on planning matters based on a “best planning outcome” and not whether the proposed development is in compliance with municipal Official Plans and Provincial Planning Policy; and

Whereas, Ontario is the only province in Canada that empowers a distinct tribunal to review and overrule local decisions applying provincially approved plans; and

Whereas, municipalities across this province are forced to spend millions of dollars defending Official Plans that have already been approved by the province in expensive, time consuming and ultimately futile OLT appeal hearings.

It is therefore recommended:

1. That the Government of Ontario dissolve the OLT immediately thereby eliminating one of the most significant sources of delay for the development of more attainable and affordable housing in Ontario; and
2. That a copy of this resolution be sent to the Honourable Doug Ford, Premier of Ontario, the Minister of Municipal Affairs and Housing, the Leader of the Opposition, the Leaders of the Liberal and Green Party, all MPPs in the Province of Ontario; and
3. That a copy of this resolution be sent to the Association of Municipalities of Ontario, the Large Urban Mayors’ Caucus of Ontario, the Small Urban GTHA Mayors and Regional Chairs of Ontario; and
4. That a copy of this resolution be sent to all Ratepayer Associations in the City of Vaughan.

14. REVIEW OF REGIONAL WINTER MAINTENANCE ROLES AND RESPONSIBILITIES

Whereas, the Regional Municipality of York and the City of Vaughan provide service excellence in its winter maintenance operations;

Whereas, sidewalk obstructions, blockages, and ice buildups are not unique to significant snow accumulations and are a regular occurrence during road clearing operations, and that this has been an ongoing issue throughout the region for the past 20 years;

Whereas, the Regional Municipality of York received a significant winter event on January 17, 2022 emphasizing current gaps in providing optimized winter maintenance services;

Whereas, the Region's response to snow accumulation can include multiple rounds of snowplow clearing from the roadway, including a benching operation to remove snow from the curb line;

Whereas, as a result of road clearing operations, bridge deck and monolithic sidewalks will often have accumulation inhibiting the ability for pedestrians to safely pass;

Whereas, as a result of road clearing operations, snow placement causes ice buildup on sidewalks, as well as obstructions and blockages on egresses leading to inability to pedestrians to safety pass and sightline concerns;

Whereas, regional road sidewalks require a disproportionate amount of time to clear creating delays in clearing residential neighbourhoods;

Whereas, the Region has undertaken snow clearing operations on boulevard bicycle lanes adjacent to regional roads; and

Whereas, it is important and useful to improve the effectiveness of the City's and Region's operations, as part of our quest for continuous improvement in providing a demonstrated consistency of services to our residents, businesses, and emergency care centres.

It is therefore recommended:

1. That Vaughan Council endorses a Notice of Motion that will be put forth by Regional Councillor Jackson to York Region Council to request that a review be undertaken regarding York Region assuming all winter maintenance including snow clearing on

sidewalks adjacent to regional roads, with the Region of York reporting back to York Region Committee of the Whole on June 16, 2022, including:
