The Heritage Vaughan Advisory Committee recommended that the following recommendations be forwarded to Council for approval:

1. That the recommendations contained in the report of the Deputy City Manager, Planning and Growth Management, dated March 22, 2023, be approved; and
2. That the comments from Pasquale Aiello, Organica Studio + Inc., Birmingham Street, Etobicoke, on behalf of the applicant, be received.

Recommendation of the Deputy City Manager, Planning and Growth Management,  
dated March 22, 2023:

1. THAT Heritage Vaughan recommend Council approve the proposed exterior renovation of the City of Vaughan Woodbridge Library at 150 Woodbridge Avenue in the Woodbridge Heritage Conservation District under Section 42 of the *Ontario Heritage Act*, subject to the following conditions:
  - a) Any significant changes to the proposal by the Owner may require reconsideration by the Heritage Vaughan Committee, which shall be determined at the discretion of the Director of Development Planning and Manager of Urban Design and Cultural Heritage;
  - b) That Heritage Vaughan Committee recommendations to Council do not constitute specific support for any Development Application under the *Ontario Planning Act* or permits currently under review or to be submitted in the future by the Owner as it relates to the subject application;
  - c) That the applicant submit Building Permit stage architectural drawings and building material specifications to the satisfaction of the Vaughan Development Planning Department, Urban Design and Cultural Heritage Division.
