Re: Item 4.1 Proposed Demolition of Existing Structure and construction of detached house at 7808 Yonge Street, Thornhill Heritage Conservation District

The Thornhill Historical Society is not supportive of the demolition of the circa 1856 home at 7808 Yonge Street. It is entirely possible for this 167-year-old building to have the "dangerous" materials remediated. There are many examples of successfully restored and inhabited historic buildings which have contained asbestos and other substances.

If the demolition is approved, the Thornhill Historical Society recommends that the windows on the most visible elevations along Yonge Street be at least 2 over 2, true-divided windows. In this way, they will not appear as modern as the rendering. This will be small compensation for the loss of yet another heritage building.
