17. NINE POINT ACTION PLAN TO FIGHT TRAFFIC GRIDLOCK

The Committee of the Whole recommends approval of the recommendations contained in the following resolution of Mayor Steven Del Duca, dated April 18, 2023.

Member's Resolution

Submitted by Mayor Steven Del Duca

Whereas, the City of Vaughan's 2022 Citizen and Business Surveys say traffic and traffic-related concerns are ranked top-of-mind by residents and businesses as the critical issues facing the community; and

Whereas, gridlock challenges are further compounded by the city's rapidly growing population. A recent forecast by York Region suggests that by 2051, Vaughan's population will increase by more than 66 per cent to be nearly 570,000; and

Whereas, reducing congestion is essential to advancing Council-approved secondary plans to develop new residential units in prominent areas throughout the city, like the Vaughan Metropolitan Centre (VMC), Weston Road and Highway 7, Yonge Street and Steeles Avenue, Vaughan Mills and the Promenade Centre; and

Whereas, addressing current and future traffic issues is paramount to implementing the Ontario Government's Housing Pledge and the City's provincially mandated housing targets to facilitate the construction of 42,000 new homes in Vaughan by 2031. Building homes in neighbourhoods with access to transit is a key part of the solution to tackling gridlock in Vaughan; and

Whereas, Vaughan Council has a successful track record of making transit a leading city-building priority with such projects as TTC Subway service into the VMC downtown core, existing and expanded Bus Rapid Transit service across Highway 7 and the proposed Yonge North Subway Extension; and

Whereas, combating gridlock is critical to local economic competitiveness. Vaughan's strategic location to 400 series highways, airports, and railways are essential to retaining and attracting economic development and jobcreating opportunities. Vaughan surpassed regional, provincial and national economic growth rates in 2021, with nearly 19,000 businesses employing more than 236,000 workers, producing a real GDP of almost \$25 billion; and

Whereas, traffic impacts residents' quality of life and the ability of families to spend more time together and travel to and from popular local amenities like community centres and sport facilities; and

Whereas, Transportation and Mobility is one of seven strategic priority areas of the Council-approved 2022-2026 Term of Council Service Excellence Strategic Plan, with a specific objective to advocate for improve Vaughan's roads and street network; and

Whereas, the City has planned or is currently underway several different transportation, mobility and infrastructure projects that will help alleviate gridlock pressures across different municipal wards; and

Whereas, to plan, fund and complete essential traffic and transportation infrastructure projects, the City must undertake effective advocacy efforts with all government levels to secure investments for projects that will not only benefit Vaughan but the entire Toronto Region – a critical region for Ontario and Canada; and

Whereas, in addition to clearly outlining vital gridlock infrastructure initiatives for funding, this effort will help to coordinate construction timelines with other government levels like York Region.

It is therefore recommended:

- 1. THAT, Vaughan Council endorse a nine point Action Plan to Fight Traffic Gridlock in Vaughan, consisting of the following projects:
 - a. Widening Highway 7 to six general-purpose lanes of traffic between Wigwoss Drive and Kipling Avenue.
 - b. Connecting Langstaff Road over the CN MacMillan Yard and upgrading the interchange at Langstaff Road and Highway 400.
 - c. Connecting Kirby Road between Dufferin and Bathurst Streets.
 - d. Connecting Teston Road between Keele and Dufferin Streets.
 - e. Building two additional east-west bridges over Highway 400, one linking Colossus Drive to the southern Vaughan Metropolitan Centre south of Highway 7; and the other linking Canada Drive and America Avenue north of Major Mackenzie Drive.
 - f. Building the extension of Bass Pro Mills Drive to Weston Road to help improve general traffic flow without negatively impacting existing residential neighbourhoods.
 - g. Continuing Council's strong support for the Yonge North Subway Extension.
 - h. Continuing Council advocacy for GO Train service for Woodbridge and Kleinburg-Nashville, and for new GO stations on the Barrie GO corridor at Concord and Kirby.
 - i. Continuing support for York Region Rapid Transit's plan to deliver Bus Rapid Transit on Jane Street, Major Mackenzie Drive and Steeles Avenue.

- 2. THAT, staff be directed to work with other government levels, stakeholders and the community to ensure the above-mentioned projects can be successfully planned, funded and completed; and
- 3. THAT, a copy of this Member's Resolution and correspondence about the Member's Resolution be sent to the federal and provincial Transportation Ministers, copying Vaughan-area Members of Parliament and Members of Provincial Parliament, York Region and Metrolinx.

18. ALL-WAY STOP AT JULIA VALENTINA AVENUE AND NOAH <u>CRESCENT</u>

Whereas, Julia Valentina Avenue is a local street with an 8.0 metre pavement width and Noah Crescent with an 8.0 metre pavement width;

Whereas, Noah Crescent/Casa Vista Drive aligning with the school driveway of St. Stephen Catholic Elementary School and in the vicinity of Sunset Ridge Park;

Whereas, the residents in the area of Julia Valentina Avenue and Noah Crescent have expressed concerns with respect to the safety concerns they have regarding the existing stop sign at this location;

Whereas, the intersection of Julia Valentina Avenue and Noah Crescent is currently under a two-way stop with stop signs located on the approaches from Noah Crescent and Casa Vista Drive;

Whereas, residents have expressed concerns with respect to there have been several near-miss collisions due to confusion with the existing stop sign; and

Whereas, the residents in the area have presented a petition requesting a minor modification.

It is therefore recommended:

1. That an all-way stop control at the intersection of Julia Valentina Avenue and Noah Crescent be approved and be installed at this location; and

Whereas, the Regional Municipality of York has approved significant capital investments to improve Regional infrastructure through a number of projects within the City of Vaughan; and

Whereas, many of these projects are in the construction phase, including improvements to Bathurst Street, Dufferin Street, Keele Street, Rutherford Road and Major Mackenzie Drive; and

Whereas, delivery of these projects require construction activities that impact transportation and mobility on Regional roads; and

Whereas, many of the these projects require lane restrictions and/or impacts to traffic movements (such as turning prohibitions); and

Whereas, a number of these projects are occurring on adjacent Regional roads that amplify the impact to the travelling public.

It is therefore recommended:

- 1. That the Region identify and implement additional strategies to communicate planned traffic disruptions and restrictions, including impacted local residents and businesses (including but not limited to electronic variable message boards and the use of paid duty officers);
- 2. That Regional staff investigate and implement appropriate strategies to optimize and improve the planning and delivery of infrastructure projects with a goal of reducing traffic disruptions; and
- 3. That City Staff provide an update to the Mayor and Members of Council on the progress (by the Region) of the actions identified above.
