

### What We Heard from the Public

Create **complete communities** that are walkable, feature cycling routes and access to shopping and employment.

Consider a broad spectrum of housing types and tenures

Encourage **intensification** in appropriate areas with **access to transit**.



Balance the continued need for traditional office space with more **flexible**, **multipurpose workspaces**.

**Protect and enhance** natural areas.





### What We Heard

Coordinate development with the provision of **services and amenities.** 

Continue to invest in **active transportation** such as walking, cycling and connections to public transit.

Integrate engagement with Indigenous Peoples into the Official Plan.



Support a community where all residents feel valued, safe, accepted, and included, reflecting the City's growing and diverse population.









#### What is new?

- Updated Urban Structure
- Strengthened Strategic Growth policies
- Included Major Transit Station Area (MTSA) policies
- Included Urban Expansion Area (Whitebelt lands) policies
- Enhanced phasing policies to guide growth through both intensification and Greenfield development
- Updated population forecasts to conform to Regional Official Plan
- Updated density targets for Employment Areas and inclusion of associated policies
- Updated policies around Agricultural System (formerly Countryside)

#### What is new?

#### **Climate Change**

- Established a dedicated climate change policy section
- Included policies around opportunities for on-site technologies that reuse waste heat and generate energy from waste recovery

#### Housing

- Included policies around providing a broader choice of housing options, including a diverse mix of housing types and tenures, including gentle density and secondary suites (Additional Residential Units)
- Enhanced and strengthened policies to achieving attainable housing







#### What is new?

#### **Urban Design**

- Enhanced guidance around the design of Privately Owned Public Spaces and complete streets
- Incorporated universal design
  - The design and composition of an environment so that it can be accessed, understood and used to the greatest extent possible by all people of all ages and abilities
- Increased focus on the role of the City-Wide Urban Design Guidelines
- Strengthened direction for design of mixed-use building typologies







#### What is new?

#### **Economy and Employment**

- Included policies to diversify employment lands for innovative industries
- Strengthened policies to develop the City's creative, cultural and tourism economic sectors
- Protected and designated appropriately sized lots for the attraction and retention of industrial and logistics sectors
- Encouraged intensification of lands in existing Employment Areas (including the lands in Employment Areas that are also in an MTSA)
- Clarified permissions for retail and office uses in Employment and Mixed-Use Areas
- Updated policies for guiding the urban design of drive-through facilities









#### What is new?

#### **Open Space and Parkland**

- Established a parkland and public space hierarchy to help ensure a diverse mix of park spaces are provided
- Developed policies to guide Parkland Strata parks and Privately Owned Public Spaces (POPS)

#### The Natural Environment and Vaughan's Natural Heritage Network

- Added policies to achieve a more streamlined chapter structure, with removal of redundant ORCMP and Greenbelt policies
- Implemented a systems approach to environmental management
- Provided guidance for the protection of ecological functions
- Added excess soil policies to guide development review









#### What is new?

#### **Cultural Heritage**

- Updated policies related to the maintenance of an Inventory of Cultural Heritage Resources
- Added an acknowledgement of the value of traditional knowledge and cultural heritage of Indigenous Peoples and the encouragement of further partnerships
- Updated Archaeological Resources policies to reflect Provincial and Regional direction
- Added policies respecting Indigenous archaeological protocols and establishing consultation requirements with Indigenous peoples

#### **Agriculture**

- Implemented an Agricultural Systems approach to conform to the Regional Official Plan and Provincial Policy
- Added Agri-Food Network policies and diversification of Agricultural Uses (Agriculture-Related Uses, On-Farm Diversified)







#### What is new?

#### **Transportation and Mobility**

- Integrated draft Vaughan Transportation Plan policies
- Prioritized and strengthened active transportation policies based on the City's Pedestrian and Bicycle Master Plan and Transportation Master Plan recommendations
- Added Complete Streets and Transportation Demand Management policies
- Added policies to support and protect the goods movement

#### Vaughan's Infrastructure

- Enhanced infrastructure phasing and pre-emptive maintenance policies, drawing on the City's Asset Management Plan, to ensure efficient use of City investment
- Established a servicing hierarchy and strengthen water and wastewater servicing policies to conform with York Region OP
- Integrated green infrastructure policies





#### What is new?

#### **Community Services and Facilities**

- Implemented a strategy for the timely provision of community centres and services in the form of community hubs
- Strengthened policies around consideration for community services and facilities (in particular, schools) in planning for complete, walkable communities, especially in Strategic Growth Areas
- Added policies to support the improvement and addition of community facilities in areas that are underserved to encourage the creation of a complete community

Land Use Designations and Permitted Building Types



#### What is new?

- Updated and re-organized land use designations and permitted building types around use type
- Designated all Agricultural Lands as Prime Agricultural to conform to Provincial and Regional mapping
- Deleted the Community Commercial Designation and included transitional policies for lands within those designations allowing for more mixed use opportunities
- Revised mixed-use development criteria within the Mid-Rise and High-Rise Mixed-Use
  Designations to require a minimum of two permitted uses within any given building

#### What is new?

- Expanded engagement and public consultation, including new policies around Indigenous engagement and the public notification process
- Enabled policies for Inclusionary Zoning and Community Planning Permit Systems
- Added policies on the delegation of minor planning matters from Council to staff, such as the by-laws under section 34 of the *Planning Act*, that are of a minor nature, like the removal of an hold "H" symbol and a housekeeping by-law for the purpose of making clerical or other changes
- Updated Section 37 policies with Community Benefits Charges policies
- Referenced the City-Wide Urban Design Guidelines and the City's Sustainability
  Metrics program in Secondary Planning
- Added Official Plan monitoring policies
- Updated the Official Plan Glossary
