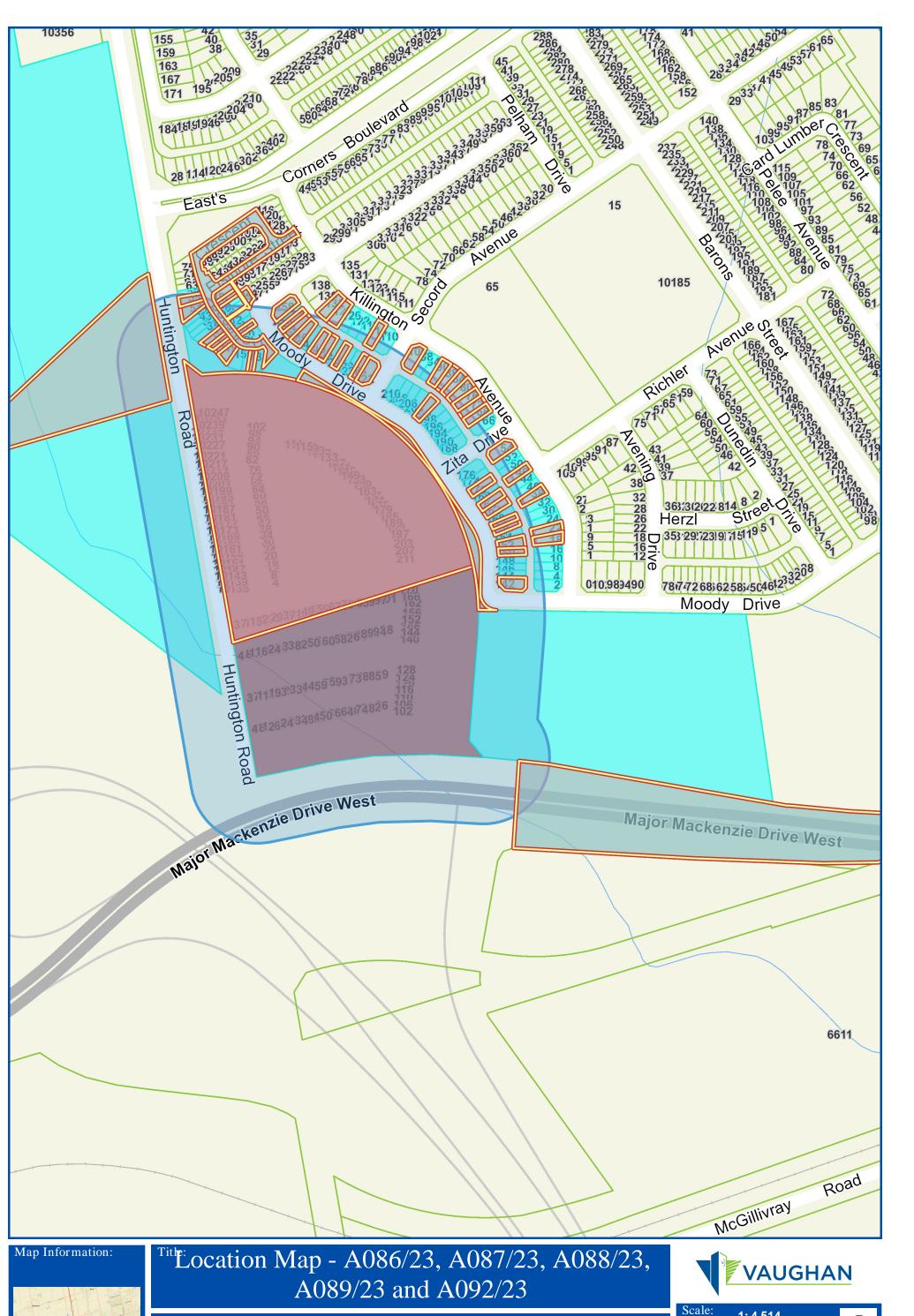



The Owner is proposing to construct four rear lane townhouses with attached garages on Block 2 of Registered Plan of Subdivision 65M-4761. Unit 2 requests relief with the above noted variance to facilitate the construction of the townhouse block.

The Development Planning Department has no objection to the proposed variance for the attached garage. Part of the intent of the by-law is to ensure the garage does not occupy the entirety of the road frontage the dwelling faces. The attached garage is located at the rear of the dwelling, accessed by a laneway, and access to the rear of the dwelling is obtained through the garage. The laneway is utilitarian in function, designed to facilitate vehicular access to the rear lane townhouses. Units 1, 3, and 4 have two parking spaces: one within an attached garage and one on a parking pad beside the garage. Unit 2 proposes a two-car garage in lieu of a parking pad and garage combination. The proposed garage is one-storey in height with no living space proposed above. As such, no adverse massing or streetscape impacts are anticipated to the neighbouring properties.

Accordingly, the Development Planning Department can support the requested variance and is of the opinion that the proposal is minor in nature, maintains the general intent and purpose of the Official Plan and Zoning By-law, and is desirable for the appropriate development of the land.
