#### **Purpose**

### **Background**

#### Month of Remembrance

The Archives division of the Office of the City Clerk has requested a proclamation for November to be recognized as Month of Remembrance on an annual basis. This proclamation would be a part of the City's annual events for the month and is a means to commemorate the service and sacrifice of Vaughan citizens and their families.

Council has previously granted this request for proclamation.

#### **Firefighters' National Memorial Day**

Vaughan Fire & Rescue Services has requested a proclamation for the second Sunday in September to be recognized as Firefighters' National Memorial Day on an annual basis.

#### **Vietnam National Day**

The National Day in Vietnam is recognized annually on September 2, commemorating a historic day for the country.

The organization has also requested a flag raising, which has been approved by the City Clerk as per the City's Flag Raising Policy.
