

***THE CITY OF VAUGHAN******BY-LAW*****BY-LAW NUMBER - 2023**

**A By-law to amend the Consolidated Parking By-law 064-2019 as amended, to govern and control parking in the City of Vaughan.**

The Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT City of Vaughan By-law 064-2019 (Consolidated) as amended, be further amended as follows:
  - a. Delete the following road segments from **Schedule 1 - No Parking**:

<b>Highway</b>	<b>Side</b>	<b>From and To</b>	<b>Prohibited Time of Day</b>
Maplecrete Road	Both	South limit of Highway m7 to 125 metres south of the south limit of Doughton Road	Anytime
Doughton Road	Both	From the east limit of Jane Street to the west limit of Creditstone Road	6:00 a.m. to 6:00 p.m. Sunday to Saturday

- b. Add the following road segments to **Schedule 1 - No Parking**:

Bent Tree Drive	Both	From 40 metres east of Millway Avenue to 80 metres west of Jane Street	Anytime

Maplecrete Road	Both	South limit of Highway m7 to Doughton Road	Anytime
Maplecrete Road	East	Doughton Road to 125 metres south of the south limit of Doughton Road	Anytime
Doughton Road	Both	From the east limit of Jane Street to 100 metres west of Maplecrete Road	6:00 a.m. to 6:00 p.m. Sunday to Saturday
Doughton Road	North	Maplecrete Road to 100 metres west of Maplecrete Road	6:00 a.m. to 6:00 p.m. Sunday to Saturday
Doughton Road	Both	Maplecrete Road to the west limit of Creditstone Road	6:00 a.m. to 6:00 p.m. Sunday to Saturday

2. THAT City of Vaughan By-law 064-2019 (Consolidated) as amended, be further amended as follows:

a. Add the following road segments to **Schedule 3 – No Stopping**:

<b>Highway</b>	<b>Side</b>	<b>From and To</b>	<b>Prohibited Time of Day</b>
Bent Tree Drive	Both	From 40 metres east of Millway Avenue to 80 metres west of Jane Street	Anytime
Bent Tree Drive	South	From Millway Avenue to 40 metres east of Millway Avenue	Anytime

3. THAT City of Vaughan By-law 064-2019 (Consolidated) as amended, be further amended as follows:

a. Add the following road segments to Schedule 4.1 – Metered On-Street Parking:

Autumn Harvest Road	South	Mable Smith Way to Millway Avenue	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.
Mable Smith Way	East	Interchange Way to Autumn Harvest Road	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.
Millway Avenue	East	Interchange Way E-W to Autumn Harvest Road	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.
Millway Avenue	West	Interchange Way E-W to Autumn Harvest Road	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.
New Park Place	North	Commerce Street to the North-South Mews	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.
New Park Place	South	Commerce Street to the North-South Mews	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.
White Elm Road	South	Maplecrete Road to Creditstone Road	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.
Maplecrete Road	West	Doughton Road to Future Freshway Drive	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.
Doughton Road	North	Commerce Street to Interchange Way N-S	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.

Doughton Road	South	Commerce Street to Interchange Way N-S	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.
Doughton Road	South	Maplecrete Road to 100 metres west of Maplecrete Road	Overnight parking prohibited from 2:00 a.m to 6:00 a.m.
