1. DEVELOPMENT REIMBURSEMENT AND CREDIT POLICY

The Committee of the Whole recommends:

- 1. That this matter be referred back to staff to develop a more reasonable approach as it relates to interest and/or indexing policies, as well as more shared risk policies;
- 2. That staff be directed to report back on the Development Charges Act and regulation policies as it relates to interest and reimbursement requirements; and

- 4. That the inclusion of this matter on a Public Committee or Council agenda with respect to the Operating Budget amendment identified in the "Resource Agreement (RA) with Metrolinx" is deemed sufficient notice pursuant to Section 2(1)(c) of By-Law 394-2002, as amended; and
- 5. That all necessary by-laws be enacted to carry out the recommendations in this report.

6. TITLE RESTRICTIONS DELEGATED AUTHORITY

- i. Highway 407 approx. 180m west of Islington Rd.

- iii. That staff of the Corporate and Strategic Communications department be authorized to manage content related to the City allocation on the subject digital signs.
