ACTION: DECISION

Purpose

To inform Council of a vacancy in the Transportation and Infrastructure Advisory Committee due to a resignation of a member and to recommend that this vacancy not be filled.

Report Highlights

- Member Daniel Henrique of the Transportation and Infrastructure Advisory Committee submitted his resignation.
- The Transportation and Infrastructure Advisory Committee is recommending that the vacancy created from Mr. Henrique not be filled.

Recommendations

- 1. That the resignation of Daniel Henrique from the Transportation and Infrastructure Advisory Committee, be received; and
- 2. That the vacancy not be filled.

Background

At the September 18, 2023 meeting of the Transportation and Infrastructure Advisory Committee, the following recommendations were approved:

- 1) That the resignation of Mr. Daniel Henrique was received; and
- 2) That the vacancy created by the resignation, not be filled.

The Transportation and Infrastructure Advisory Committee is a committee which has its' members appointed by Council. Its mandate is to encourage community involvement and advise on:

- Transportation priorities outlined in the Transportation & Infrastructure Task
 Force Findings and Recommendations Report (April 2022), the Vaughan
 Transportation Plan, the MoveSmart Mobility Management Strategy, the
 Pedestrian and Bicycle Master Plan, other applicable transportation and
 infrastructure plans, and initiatives warranting additional consideration, as
 referred by Council.
- Identifications of new revenue sources to implement these priorities

At the Council meeting of June 20, 2023 Council approved the appointment of citizens to the advisory committee. The membership is composed of two (2) Council members, and ten (10) citizen representatives, with the Mayor as ex-officio.

Members are to be appointed by Council. Any changes to the membership will require Council approval.
