#### **Purpose**

To inform Council of the resignation of a Member of Council from the Anti-Hate, Diversity and Inclusion Advisory Committee, and request direction with respect to filling the vacancy, prior to the inaugural meeting of the Advisory Committee.

#### Report Highlights

- The City Clerk received a verbal resignation from Regional Councillor Mario Ferri with respect to his position as Member of the Anti-Hate, Diversity and Inclusion Advisory Committee.
- The Terms of Reference indicates that two Members of City Council will serve as Chair.
- The Inaugural Meeting of the Anti-Hate, Diversity and Inclusion Advisory Committee will take place on October 16, 2023.

#### **Background**

The Anti-Hate, Diversity and Inclusion Advisory Committee was established by Council at the Committee of the Whole meeting of December 12, 2022. Its mandate is to provide support to staff in the implementation of the Diversity, Equity and Inclusion Plan, and provide a forum for consultation, feedback and discussion on matters of diversity, equity, inclusion, belonging and anti-hate in the City.

At the December 12<sup>th</sup> meeting, Council Members were also appointed to non-statutory committees for the 2022 – 2026 Term of Council, including the following appointments to the Anti-Hate, Diversity and Inclusion Advisory Committee:

Councillor Gila Martow, Chair Regional Councillor Mario Ferri, Member

The Terms of Reference was approved at the Committee of the Whole meeting of May 9, 2023. It indicates Membership, as follows:

- a. Two Members of City Council will serve as Chair;
- b. The Mayor will serve as an ex-officio member of the advisory committee; and
- c. Up to 10 citizen members.

Nine citizen members were appointed at the Council meeting of June 20, 2023.

At the call of the chair, the inaugural meeting of the Anti-Hate, Diversity and Inclusion Advisory Committee has been scheduled for October 16, 2023.

On September 26, 2023, the City Clerk received a verbal resignation from Regional Councillor Mario Ferri with respect to his position as Member.
