

# CITY OF VAUGHAN REPORT NO. 46 OF THE COMMITTEE OF THE WHOLE

#### 1. COUNCIL EXPENSE POLICY

The Committee of the Whole recommends approval of the recommendations contained in the following report of the Deputy City Manager, Corporate Services, City Treasurer and Chief Financial Officer, dated November 7, 2023:

#### **Recommendations**

#### 2. COUNCILLOR DISCRETIONARY BUDGET

#### 6. AMPS BY-LAW AMENDMENTS

The Committee of the Whole recommends approval of the recommendations contained in the following report of the Deputy City Manager, Community Services, dated November 7, 2023:

#### Recommendations

- 1. THAT the City's Encroachment By-law 034-2017 be amended to strengthen enforcement provisions by adding the By-law as a designated by-law under the Administrative Monetary Penalties By-law and that non-compliance under the By-law be liable to a monetary penalty of \$400 for every offence;
- 2. THAT the City's Nuisance By-law 195-2000 be amended to strengthen enforcement provisions by adding the By-law as a designated by-law under the Administrative Monetary Penalties By-law and that non-compliance under the By-law be liable to a monetary penalty of \$450 for every offence;
- 3. THAT the City's Sign By-law 140-2018 be amended to strengthen enforcement provisions by adding the By-law as a designated by-law under the Administrative Monetary Penalties By-law and that non-compliance under the By-law be liable to a monetary penalty of \$400 for every offence;
- 4. THAT the City's Waste Collection By-law 135-2017 be amended to strengthen enforcement provisions by adding the By-law as a designated by-law under the Administrative Monetary Penalties By-law and that non-compliance under the By-law be liable to a monetary penalty of \$350 for every offence;
- 5. THAT the City's Anti-Graffiti By-law 46-2009 be amended to strengthen enforcement provisions by adding the By-law as a designated by-law under the Administrative Monetary Penalties By-

- law and that non-compliance under the By-law be liable to a monetary penalty of \$400 for every offence; and
- 6. THAT the City's Administrative Monetary Penalties By-law 063-2019 be amended by adding the above by-laws as designated by-laws, with no other material changes to the By-law, and in a manner satisfactory to the City Solicitor.

### 7. MOTION ITEM 3 REPORT 1 AHDI - CITY OF VAUGHAN SUPPORTS JEWISH COMMUNITY IN TIME OF CRISIS (TRANSMITTAL REPORT)

The Committee of the Whole recommends approval of the recommendations contained in the following report of the Anti-Hate, Diversity and Inclusion Advisory Committee, dated November 7, 2023:

#### **Recommendations**

The Anti-Hate, Diversity and Inclusion Advisory Committee forwards the following recommendations from its meeting of October 16, 2023 (Item 3, Report No. 1), for consideration:

1. That the Anti-Hate, Diversity and Inclusion Advisory Committee supports the following draft Member's Resolution of Councillor Martow, in its substantive form, as amended by the Committee, and subject to minor amendments:

#### Member's Resolution

Submitted by Councillor Martow:

Whereas, during the October 11, 2023, Committee of the Whole (2) meeting of Vaughan City Council, in a recorded vote, Councillors unanimously endorsed a Members' Resolution by Mayor Steven Del Duca and Ward 5 Councillor Gila Martow that the City of Vaughan stands with the people of Israel and offers its sincerest condolences to the families of the innocent lives lost due to the ongoing, egregious acts of violence from Hamas; and

**Whereas,** as violence ensues, the safety and well-being of innocent civilians, in Israel and Gaza, is of great concern and must be a top priority as part of the international community's response efforts; and

**Whereas,** the October 16, 2023, meeting of the Anti-Hate, Diversity and Inclusion Advisory Committee marks the first time this Committee is meeting since reports of the latest terrorist acts began by Hamas on October 7.

#### It is therefore recommended:

- THAT the Anti-Hate, Diversity and Inclusion Advisory
   Committee endorse the October 11 Members' Resolution –
   Solidarity with Israel, by Mayor Del Duca and Councillor
   Martow, which unequivocally condemns the heinous acts of
   violence and terrorism by Hamas; and
- 2. THAT the Anti-Hate, Diversity and Inclusion Advisory
  Committee applaud the Federal Government for providing an
  initial \$10 million in funding for humanitarian assistance in
  response to recent appeals from experienced and trusted
  humanitarian partners to address urgent needs stemming
  from the crisis in Israel, the West Bank and Gaza; and
- 3. THAT the Anti-Hate, Diversity and Inclusion Advisory Committee further recognize and welcome today's announcement (October 16, 2023) of the appointment of Deborah Lyons as the Government of Canada's new Special Envoy on Preserving Holocaust Remembrance and Combatting Antisemitism, and that Mayor Del Duca write to Special Envoy Lyons inquiring about what Canada's cities can further do to combat antisemitism, *islamophobia*, and all forms of hate and discrimination; and
- 4. THAT the Anti-Hate, Diversity and Inclusion Advisory Committee reaffirms the United Nations Secretary-General's calls for Hamas to release the hostages immediately without conditions, and that there must be steadfast compliance with international humanitarian law; and
- 5. THAT we call for the immediate return of fuel, medicines, and other essential supplies to hospitals and aid agencies in the Gaza Strip, condemning the thefts and looting of these essential supplies, and emphasizing that ensuring access to basic necessities is the fundamental role of a government; and
- 6. THAT we urge all governments and aid agencies to ensure that civilians are not harmed and that they be permitted to leave combat zones, while condemning any reports alleging that Palestinian civilians have been prevented by Hamas forces from leaving the area, and insisting on a thorough investigation and condemnation if such reports are found to be true.
- 2. That the Member's Resolution be forwarded to Council for approval.
