BY-LAW NUMBER 209-2023

A By-law to amend Traffic By-law 284-94 as amended, to govern and control traffic in the City of Vaughan.

WHEREAS section 11(3) of the Municipal Act, 2001, S.O. 2001, c. 25 (the “Municipal Act”), as amended, provide for lower-tier municipalities to pass by-laws respecting matters pertaining to highways, including parking and traffic on highways, and parking, except on highways;

WHEREAS By-law 284-94, as amended, of The Corporation of the City of Vaughan regulates traffic on roads under the jurisdiction of the City of Vaughan;

AND WHEREAS the Council of the Corporation of the City of Vaughan deems it necessary to add additional parking prohibitions on certain highways within its jurisdiction;

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT City of Vaughan By-law 284-94, as amended, be and is hereby further amended by adding the following provision to Schedule “B”, Part 2 Multi-way Stops:

3. THAT City of Vaughan By-law 284-94, as amended, be and is hereby further amended by adding the following provision to Schedule “E”, Part 1 Speed Limit By-Law – 40 km/hr:

Background Report

The City’s Comprehensive Traffic By-Law 284-94 designates such things as speed limit control, stop controls, load restrictions, turn prohibitions, pedestrian crossovers, and cycle tracks on the City of Vaughan’s (the City) network of roadways.

As new streets are established through development, it is necessary to amend Traffic By-Law 284-94 to include all new signage in accordance with the Ontario Traffic Manual and City standards. The new signage on new streets includes “Multi-way stops”, “Yield streets”, “Speed limits”, “Prohibited turns”, “Pedestrian crossovers” and “Cycle tracks”.

The draft Traffic by-law update captures the majority of the “Multi-way stops”, “Yield streets”, “Speed limits”, “Prohibited turns”, “Pedestrian crossovers” and “Cycle tracks” that were constructed and dedicated as public highway between January 2023 and December 2023, as shown on Attachments 1 and 2, inclusive.

The draft by-law of Traffic By-law update will form the amendment to Traffic By-Law 284-94, Schedules “B”, “E”, “F”, “G”, and “H”.

The Traffic By-Law 284-94 will be amended as development proceeds on a regular basis going forward.

Accordingly, we recommend that the City enact the attached draft by-law as authorized in Delegation By-law 005-2018.


