I am a resident of the Vellore Woods area who received the notice of the new zoning amendment for 7 High-rise towers at Major Mackenzie and Weston Road.

When we decided to buy a new build home, one of the main reasons why we chose this area was because it is quaint, has beautiful parks and schools nearby and is a great area to raise a family. We did not build our \$1.5 million dollar dream home in a quiet ravine area only to receive this disappointing notice one year after settling in.
