ACTION: DECISION

Purpose

To seek approval for the proclamation request received for World Down Syndrome Day/Vaughan Down Syndrome Day.

Report Highlights

- Respond to the request received by the Down Syndrome Association of York Region.
- Proclamation is requested for the date of March 21, 2022.

Recommendations

- 1. That March 21, 2022 be proclaimed as "World Down Syndrome Day/Vaughan Down Syndrome Day";
- 2. That this item be approved at the Committee of the Whole meeting of March 8, 2022, so that the City can appropriately observe and raise awareness of the campaign on the requested day of March 21, 2022;
- 3. That Council ratify these recommendations at the Council meeting of March 22, 2022; and,
- 4. That the proclamation be posted on the City's website and the Corporate and Strategic Communications department be directed to promote the above-noted proclamation through the various corporate channels.

Background

The Down Syndrome Association of York Region exists to serve and support those in York Region who have Down Syndrome and to raise awareness about Down Syndrome in the community at large.

World Down Syndrome Day is held on March 21 each year. It is a global awareness day which has been observed by the United Nations since 2012. The Province of Ontario has also proclaimed March 21 to be Ontario Down Syndrome Day in past years. City of Vaughan Council has previously granted this request.

Additionally, the organization has put forward a request for flag raising and a request for illumination for the date of March 21, 2022. As per the Flag Raising Policy (03.C.11) and the Illumination Policy (03.C.12), the City Clerk has reviewed and approved the requests.
