## **Background**

The request for proclamation was received from Findhelp Information Services (Findhelp | 211) on January 8, 2023.

As per information provided by the organization, 211 provides residents of Vaughan and across the country with information and referral to the complete range of government, health, community and social services in their communities. 211 is a free and confidential service available 24/7 in 150+ languages by phone. 211 is funded and supported by the United Way Greater Toronto.

Council has previously approved this request for proclamation, in 2023. An illumination request for the date of February 11, 2024, has been approved by the City Clerk, as per the City's Illumination Policy 03.C.12.
