Applicant Justification for Variances: <small>*As provided by Applicant in Application Form</small>	<p>A variance is required for height. The main roof height is within the maximum permitted height, however a clerestory that occupies a small percentage of the main roof extends above the main roof height, thereby increasing the overall building height above the permitted amount. The clerestory is setback substantially from all sides of the house to minimize impact.</p> <p>A variance is required for lot coverage. The proposed dwelling includes an indoor pool, so the owner has year round use of the amenity. The indoor pool adds to the proposed lot coverage, whereas an outdoor pool would not be included in lot coverage. In addition to the indoor pool, a front canopy extends over a portion of the driveway and a rear canopy extends over the rear yard patio. The portion of the indoor pool which extends beyond the envelope of the 2nd floor above, combined with the front and rear yard canopies accounts for 5.2% of the total proposed 20.7% lot coverage.</p>

Building Permit(s) Issued: A Building Permit has not been issued. The Ontario Building Code requires a building permit for structures that exceed 10m2

The applicant shall be advised that additional variances may be required upon review of detailed drawing for building permit/site plan approval.

The subject lands may be subject to Ontario Regulation 166/06 (TRCA - Toronto and Region Conservation Authority).

The subject lands may be subject to the Oak Ridges Moraine Conservation Act, RSO 2001. Please note as of January 1, 2015 Accessible Parking Spaces are subject to the provisions of Ontario Regulation - O.Reg.413/12, Subsections 80.32 through 80.39, which supersede the current by-law requirements in By-law 1-88 as amended.

Please note Section 4.1.1(b) that states the maximum height of an accessory building or structure measured from the average finished ground level to the highest point of the said building or structure shall be 4.5 metres. The nearest part of the roof shall not be more than three(3) metres above finished grade.

An A/C unit and/or pool equipment shall be setback a minimum of 1.2 metres from the interior side lot line; and may encroach a maximum of 1.5 metres into the required rear yard or exterior side yard.

As the proposed dwelling in the subject property is 667.49 m2, the owner/ applicant needs to obtain a lot grading permit from Development Inspection and Lot Grading division of the City's Development Engineering Department. Please note any in ground structure over 10 m2 requires a grading permit. Please contact COA application engineering reviewer after receiving the grading permit to clear the condition.

The proposed work by the owner is increasing the lot coverage in the subject property. The added hardscape may have impact on City's Storm Water management system. Stuff requires the owner/applicant to introduce Low-impact Development (LID) measures (Bioswales, Permeable pavers, Rain Gardens, Rain Barrels etc.) to reduce the impacts. Please provide DE with a LID brief explaining the measures taken prior to clearing the condition.

The owner/applicant shall apply and obtain the necessary curb cut/ reinstating permit through the Transportation and Fleet Management Services. 

Alectra Utilities (formerly PowerStream) has received and reviewed the proposed Variance Application. This review, however, does not imply any approval of the project or plan.

All proposed billboards, signs, and other structures associated with the project or plan must maintain minimum clearances to the existing overhead or underground electrical distribution system as specified by the applicable standards, codes and acts referenced.

In the event that construction commences, and the clearance between any component of the work/structure and the adjacent existing overhead and underground electrical distribution system violates the Occupational Health and Safety Act, the customer will be responsible for 100% of the costs associated with Alectra making the work area safe. All construction work will be required to stop until the safe limits of approach can be established.

Official Plan:

Vaughan Official Plan 2010 ('VOP 2010'): "Oak Ridges Moraine Countryside" and "Oak Ridges Moraine Natural Areas"

Comments:

The Owner is requesting permission to construct a two-storey single detached dwelling with the above noted variances.

At the request of the Development Planning Department, the Owner has reduced the proposed curb cut from 7.21 m to 5.96 m, which eliminated the variance for maximum curb cut.

The proposed maximum lot coverage of 20.72% is divided between the main dwelling (incl. indoor pool area) occupying 15.8%, while the remaining 4.92% is contributed to the overhangs and canopies which are considered non-livable areas. The proposed lot coverage also complies with By-law 01-2021. The proposed building height of 10.84 m remains consistent with recent approvals for 2-storey dwellings in the area. Both the maximum lot coverage and height are appropriate given the scale and character of the existing neighbourhood and the size of the lot. For the 3.18 m setback to a retaining wall, the reduction is minimal and appropriate in this site context.

In support of the application, the Owner submitted an Arborist Report, Tree Protection Plan and Forest Edge Management Plan, prepared by Cohen & Master Tree and Shrub Services, dated September 3, 2021, to identify which trees will be removed, protected, and potentially impacted by the proposal. The Urban Design Division of the Development Planning Department has reviewed the report and are generally satisfied with its recommendations. All proposed works identified in the Arborist report will be managed and reviewed by Parks, Forestry and Horticulture Operations staff, through the tree permit process.

The Policy Planning and Environmental Sustainability ('PPES') Department have reviewed the application and can support the location of the proposed septic tank as it causes the least impacts to the adjacent woodlot compared to an alternate location. Additionally, PPES have reviewed the submitted Forest Edge Management Plan and have no further comments.

The Development Planning Department is of the opinion that the proposal is minor in nature, maintains the general intent and purpose of the Official Plan and Zoning By-law, and is desirable for the appropriate development of the land.

Recommendation:

The Development Planning Department recommends approval of the application.
