# *BY-LAW*

## BY-LAW NUMBER 027-2024

**A By-law of the Corporation of the City of Vaughan to amend Animal Control By-law 066-2020, as amended.**

**WHEREAS** section 8(1) of *Municipal Act*, 2001, S.O. 2001, c. 25, as amended, (the "*Municipal Act*") provides that the powers of a municipality shall be interpreted broadly as to confer broad authority on a municipality to (a) enable it to govern its affairs as it considers appropriate, and (b) enhance its ability to respond to municipal issues;

**AND WHEREAS** the City seeks to update references to outdated by-laws and clarify the non-refundable nature of certain fees;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan **ENACTS AS FOLLOWS:**

1. That Animal Control By-law 066-2020, as amended, be further amended by adding the following definitions in alphabetical order to 3.0(1):
  - "Administrative Monetary Penalties By-law" refers to the City's Administrative Monetary Penalties By-law 063-2019, as amended, or its successor by-law;
  - "Business Licensing By-law" refers to the City's Business Licensing By-law 122-2022, as amended, or its successor by-law;
  - "Fees and Charges By-law" refers to the City's Fees and Charges By-law 224-2023, as amended, or its successor by-law;
  - "Zoning By-law" refers to the City's Zoning By-law 001-2021, as amended, or its successor by-law;
2. That Animal Control By-law 066-2020, as amended, be further amended by repealing all references to "Licensing By-law 315-2005" and replacing them with "the Business Licensing By-law".
3. That Animal Control By-law 066-2020, as amended, be further amended by repealing all references to "Fees and Charges By-law 171-2013" and replacing them with "the Fees and Charges By-law".

4. That Animal Control By-law 066-2020, as amended, be further amended by repealing all references to “Zoning By-law 1-88” and replacing them with “the Zoning By-law”.
5. That Animal Control By-law 066-2020, as amended, be further amended by repealing all references to “Administrative Monetary Penalties By-law 063-2019” and replacing them with “the Administrative Monetary Penalties By-law”.
6. That Animal Control By-law 066-2020, as amended, be further amended by adding the word “non-refundable” before the word “fee” in subsection 4.0(1)(c).
7. That Animal Control By-law 066-2020, as amended, be further amended by adding subsection 5.0(1)(d) to read as follows:
  - (d) pay the applicable non-refundable fee, as set out in the Fees and Charges By-law.
