






BLOCK 17 (BLOCK Q) 1 : 200

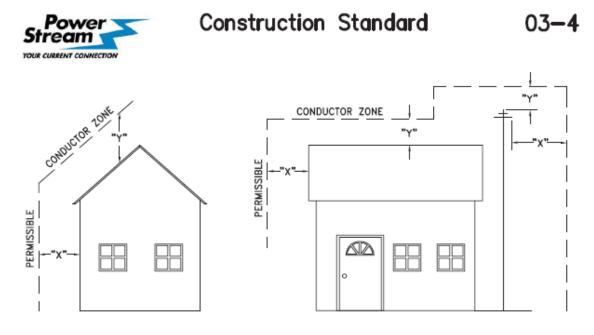

The Owner is requesting permission to reduce the minimum setback to a daylight triangle at the intersection of Mable Smith Way and Autumn Harvest Road to facilitate the previously approved applications (File OP.18.014, Z.18.021, 19T-18V008, and DA.18.056) that permit the development of three (3) residential midrise and twenty (20) blocks of townhomes. Council approved the above noted files on April 2, 2019 (Files OP.18.014, Z.18.021, & 19T-18V008), and September 17, 2019 (File DA.18.056), respectively.

Development Planning has no objection to the Variance, as a 0.3 m reduction in minimum setback only applies to the south-west corner of Townhouse Block 17, Unit 257. Transportation Engineering of the VMC Program has reviewed the proposed change and is of the opinion it does not impact the functionality of the intersection for vehicular usage. Recognizing the remainder of the Development is compliant with Council's approval and this minor deviation at the south-west intersection is derived from the result of a siting error Development Planning and Development Engineering are generally satisfied.

The Development Planning Department is of the opinion that the requested Variance is minor in nature, maintains the general intent and purpose of the Official Plan and Zoning By-laws, and is desirable for the appropriate development of the land.

Recommendation:

The Development Planning Department recommends approval of the application.
