#### **Purpose**

To receive comments from the public and the Committee of the Whole on a City initiated city-wide zoning by-law amendment to permit Seasonal Temporary Outdoor Patios and expand existing Outdoor Patios accessory to Restaurants and Banquet Halls, and to amend the City's Site Plan Control By-law 123-2013. The permissions for Seasonal Temporary Outdoor Patios would apply between May 1 and November 1 of each year.

### **Report Highlights**

- The City proposes Zoning By-law Amendments to By-laws 1-88 and 001-2021 to permit Seasonal Temporary Outdoor Patios on an annual basis.
- The City's Site Plan Control By-law is also proposed to be amended to waive the requirement for a Site Development Application to implement Seasonal Temporary Outdoor Patios.
- A technical report prepared by the Development Planning Department in consultation with the Building Standards, Development Engineering, and By-law and Compliance, Licensing and Permit Services Departments will be considered at a future Committee of the Whole meeting.

#### Recommendations

1. THAT the Public Meeting report for Zoning By-law Amendment Z.23.028 (City of Vaughan) BE RECEIVED, and that any issues identified be addressed by the Development Planning Department in a comprehensive report to the Committee of the Whole.

#### **Background**

Location: City-wide

On October 20, 2021, Council adopted the new CZBL. The OLT ordered the CZBL into force by its order on December 28, 2022, and as corrected on March 28, 2023, with exceptions.

The CZBL affects all lands within the City of Vaughan, except for lands in the vicinity of Yonge Street and Steeles Avenue West, as shown on Attachment 1, and any lands subject to outstanding site-specific appeals. The CZBL replaces Zoning By-law 1-88 except for matters of transition pursuant to Section 1.6 of the CZBL, and the Yonge-Steeles Corridor Secondary Plan Area. The CZBL has been appealed to the OLT by a number of appellants. The OLT issued an Order on December 28, 2022, which was subsequently corrected on March 28, 2023, bringing into effect all sections of the CZBL that have not been appealed.

## Temporary Outdoor Patios were previously approved by Vaughan Council during the COVID-19 Pandemic.

On June 29, 2020, Vaughan Council approved a City-initiated Zoning By-law Amendment (File Z.20.017) and passed the associated temporary use By-law 094-2020 to permit the use of temporary outdoor patios accessory to a Restaurant or Banquet Hall subject to the required zoning standards identified in the by-law. The duration of By-law 094-2020 initially spanned the period in which the Province of Ontario declared an emergency to exist under Section 4 of the *Emergency Management and Civil Protection Act* (the 'Emergency Order') related to the COVID-19 pandemic, or up until November 2, 2020, whichever came first.

The intention of By-law 094-2020 was to allow Restaurants and Banquet Halls to temporarily continue operating outdoors while indoor dining was not permitted during the COVID-19 pandemic. By-law 094-2020 was further amended by By-law 148-2020 to extend the temporary use permissions to no longer than 14 days beyond the lifting of the Emergency Order, irrespective of the November 2, 2020, date. The Province of Ontario lifted the Emergency Order on July 24, 2022.

The temporary outdoor patio permissions received largely positive feedback from the industry and patrons, and the City did not experience significant enforcement issues or complaints from the public. With the temporary outdoor patio permissions now expired, the City has an interest in reintroducing permissions on a permanent basis to provide opportunities for Restaurant and Banquet Hall uses to erect temporary outdoor patios on a recurring seasonal basis to support businesses in the City.

## The City has initiated a Zoning By-law Amendment to permit seasonal outdoor patios accessory to Restaurants and Banquet Halls

The City has initiated City-wide Zoning By-law Amendment file Z.22.029 to amend both by-laws 001-2021 and 1-88 and permit Seasonal Temporary Outdoor Patios for Restaurant and Banquet Hall uses along with the draft zoning standards shown in Attachments 2 and 3 (the 'Amendment').

## Public Notice was provided in accordance with the Planning Act and Council's Notification Protocol

a) Date the Notice of Public Meeting was circulated: February 9, 2024

The Notice of Public Meeting was posted on the City's website at www.vaughan.ca and published in the February 7, 2024, edition of the Toronto Star.

- b) The By-law and Compliance, Licensing and Permit Services Department conducted a business survey on February 15, 2024 to obtain feedback on the proposed permissions for seasonal temporary outdoor patios.
- c) No comments have been received directly by the Development Planning Department as of February 20, 2024.

Any written comments received will be forwarded to the Office of the City Clerk to be distributed to the Committee of the Whole as a Communication and be reviewed and addressed by the Development Planning Department in a future technical report to the Committee of the Whole.

### **Analysis and Options**

Seasonal Temporary Outdoor Patios accessory to Restaurant and legally existing Banquet Hall Uses are permitted by the Vaughan Official Plan 2010.

- The Vaughan Official Plan 2010 ('VOP 2010') permits Restaurants (which are defined as "Retail" for the purpose of VOP 2010) in the following land use designations identified on Schedule 13 Land Use:
  - "Low-Rise Mixed-Use", "Mid-Rise Mixed-Use", "High-Rise Mixed-Use",
     "Community Commercial Mixed-Use", "Downtown Mixed-Use" and "Major Institutional";
  - "Employment Commercial Mixed-Use" subject to a maximum Gross Floor Area ('GFA') of 3,500 m<sup>2</sup> per unit;

- "Prestige Employment" provided they are accessory and directly associated to a primary use, or are ancillary subject to locational criteria and a maximum GFA of 185 m² per unit and the total GFA of all ancillary uses does not exceed 20% of the total GFA of any one lot; and
- o "Theme Park and Entertainment" where they are directly associated with the Theme Park Use.
- VOP 2010 does not expressly permit Banquet Halls in any land use designation; however, Section 10.2.1.4 of VOP 2010 recognizes legally existing land uses as they exist at the time VOP 2010 was approved, which may include existing Restaurant and Banquet Hall uses located across the City within various land use designations.
- The Amendment would permit Seasonal Temporary Outdoor Patios on a recurring basis for Restaurants and Banquet Halls which are permitted as of right by the Zoning By-law, or are legally existing as of the date of the amendment.
- The proposal conforms to VOP 2010.

## A Zoning By-law Amendment is required to permit the seasonal temporary Outdoor Patios.

#### Zoning By-law 1-88:

- Zoning By-law 1-88 continues to apply to lands subject to ongoing site-specific appeals to Zoning by-law 001-2021, matters of Transition under Section 1.6 of the CZBL, and the Yonge and Steeles area
- Outdoor Patios accessory to an Eating Establishment (Restaurant) are permitted.
- A Banquet Hall is also permitted to contain an Eating Establishment up to a maximum 20% GFA of the building, which may also have an accessory Outdoor Patio.

#### Zoning By-law 001-2021:

- Zoning By-law 001-2021 applies to all other areas of the City.
- Outdoor Patios accessory to a Restaurant are permitted.
- A Banquet Hall is also permitted to contain the incidental preparation and sale of food and beverages.

The Amendment would establish the definition of a Seasonal Temporary Outdoor Patio and related development standards in both Zoning By-laws 1-88 and 001-2021 to permit their use accessory to a Restaurant or Banquet Hall. The use would be permitted to operate between May 1 and November 1 every year, except in 2024 where the use is expected to be permitted starting May 28 after the last day of the by-law appeal period. Draft zoning standards are included in Attachments 2 and 3. Additional standards may be identified through continued review and feedback of the Amendment and considered in a technical report to a future Committee of the Whole meeting.

#### An amendment to Site Plan Control By-law 123-2013 is required.

Site Plan Control By-law 123-2013 designates the City as a Site Plan Control Area pursuant to Subsection 41(2) of the *Planning Act*, and requires certain classes of development to be subject to Site Plan Control, including Outdoor Patios. An amendment to Site Plan Control By-law 123-2013 is required to exempt the temporary

Outdoor Patios from the provisions of Site Plan Control. A draft Site Plan Control amendment by-law is included as Attachment 4.

Following a preliminary review of the applications, the Development Planning Department has identified the following matters to be reviewed in greater detail:

<u>Financial Impact</u>
There are no financial requirements for new funding associated with this report.

#### **Operational Impact**

The Development Planning Department, in consultation with the Building Standards, Development Engineering, and By-law and Compliance, Licensing and Permit Services Departments have developed the Draft Zoning By-laws under Attachments 2 and 3, which demonstrate preliminary zoning standards for Seasonal Temporary Outdoor Patios. Through further consultation, the draft By-laws will be finalized and forwarded to a future Council meeting.

#### **Broader Regional Impacts/Considerations**

There are no broader regional impacts or considerations associated with this report.

#### **Conclusion**

The preliminary issues identified in this report and any other issues identified through the processing of the Application will be considered in the technical review of the Application. Comments from the public and Vaughan Council expressed at the Public Meeting or in writing will be addressed in a comprehensive report to a future Committee of the Whole meeting.



#### **BY-LAW NUMBER XXX-2024**

A By-law to amend City of Vaughan By-law 1-88, as amended.

WHEREAS the matters herein set out are in conformity with the Official Plan of the Vaughan Planning Area, which is approved and in force at this time;

**AND WHEREAS** there has been no amendment to the Vaughan Official Plan adopted by Council but not approved at this time, with which the matters herein set out are not in conformity;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- 1. That City of Vaughan By-law Number 1-88, as amended, be and it is hereby further amended by:
  - Adding the definition of "Seasonal Temporary Outdoor Patio" under Part 2.0,
     Definitions, Part 2.2, Vaughan Metropolitan Centre Definitions and Part 2.3,
     Carville Centre Definitions as follows:
    - "Seasonal Temporary Outdoor Patio: Means a temporary uncovered area located outside of a building used for the accommodation of patrons of an Eating Establishment, Restaurant or Banquet Hall use."
  - b) Deleting paragraph 5.1.1.f)ii) and replacing with the following:
    - ii) Outdoor Patios and Seasonal Temporary Outdoor Patios shall be permitted within the required landscape strip.
  - c) Renumbering paragraph "5.1.6 Outdoor Patio" to "5.1.6.1 Outdoor Patio".
  - d) Adding a new paragraph 5.1.6.2 to Part "5.1 General Provisions" as follows:"5.1.6.2 <u>Seasonal Temporary Outdoor Patio</u>

A seasonal temporary outdoor patio shall only be permitted as an accessory use to an "Eating Establishment", "Convenience Eating Establishment", "Convenience Eating Establishment with Drive-Through", "Restaurant" or "Banquet Hall", and only in accordance with the following provisions:

- Any lighting facilities illuminating a seasonal temporary outdoor patio shall be arranged so as to deflect light away from adjoining properties and streets;
- b) The use of musical instruments, or other mechanical or electrical music equipment, and dancing, theatrical performances or audiovisual presentations, music concerts and shows, shall not be permitted in areas designated for seasonal temporary outdoor patio use;
- c) A seasonal temporary outdoor patio shall not occupy or obstruct any accessible parking spaces, aisles, loading spaces and vehicular circulation routes for the site;
- d) A seasonal temporary outdoor patio may occupy parking spaces that are not intended for a residential use and are abutting a building which contains an eating establishment, restaurant or banquet hall use to which the seasonal temporary outdoor patio is accessory, and not be separated by aisles, loading spaces or vehicular circulation routes;
- e) In a multi-unit building, a seasonal temporary outdoor patio shall not extend beyond the width of the unit where the eating establishment, restaurant or banquet hall use is located;
- f) A seasonal temporary outdoor patio shall not impede pedestrian or vehicular access to the site:

#### Potential Parking Standards

g) Additional parking shall not be required for a seasonal temporary outdoor patio;

# OR A COMBINATION OF PROVISIONS NOTED BELOW, BUT NOT LIMITED TO

- h) A seasonal temporary outdoor patio shall not exceed ##% of the gross floor area of the principal use in conjunction with which the seasonal temporary outdoor patio use is permitted;
- i) A seasonal temporary outdoor patio may occupy no more than #
   existing parking spaces; and

- j) In a multi-unit building, a seasonal temporary outdoor patio shall not extend beyond the width of the unit where the restaurant or banquet hall use is located.
- e) A seasonal temporary outdoor patio shall be permitted in any Zone where an eating establishment, restaurant or banquet hall is permitted.
- 2. Schedules "1" and "2" shall be and hereby form part of this By-law.

The purpose of this By-law is to permit the use of seasonal temporary outdoor patios for Eating Establishment, Restaurant and Banquet Hall uses on a seasonal basis.

#### **BY-LAW NUMBER XXX-2024**

A By-law to amend City of Vaughan By-law 001-2021, as amended.

**WHEREAS** the matters herein set out are in conformity with the Official Plan of the Vaughan Planning Area, which is approved and in force at this time;

**AND WHEREAS** there has been no amendment to the Vaughan Official Plan adopted by Council but not approved at this time, with which the matters herein set out are not in conformity;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- 1. That City of Vaughan By-law Number 001-2021, as amended, be and it is hereby further amended by:
  - a) Adding the definition of "Seasonal Temporary Outdoor Patio" under Part 3.0
     Definitions as follows:
    - "Seasonal Temporary Outdoor Patio: Means a temporary uncovered area located outside of a building used for the accommodation of patrons of a Restaurant or Banquet Hall use."
  - b) Amending "Table 4-1: Permitted Encroachments into Required Yards" by deleting the row titled "<u>Outdoor Patio</u>" and replacing it with a new row titled "<u>Outdoor Patio</u> or <u>Seasonal Temporary Outdoor Patio</u>" under the "Structure or Feature" category in alphabetical order as follows:

c) Deleting paragraph 5.10.6 and replacing it with the following:

- "An <u>outdoor patio</u> or <u>seasonal temporary outdoor patio</u> in association with <u>micro-manufacturing</u> shall be prohibited, unless expressly permitted by the <u>zone</u> in which the <u>micro-manufacturing use</u> is located."
- d) Renumbering paragraph "5.12 Outdoor Patio" to "5.12.1 Outdoor Patio".
- e) Adding a new paragraph 5.12.2 to Part 5.0: Specific Use Permissions as follows:
  - "5.12.2 Seasonal Temporary Outdoor Patio
  - 1. A <u>seasonal temporary outdoor patio</u> shall only be permitted as an <u>accessory use</u> to a <u>restaurant</u> or <u>banquet hall use</u> and only where a <u>seasonal temporary outdoor patio</u> is expressly permitted by this By-law.
  - A <u>seasonal temporary outdoor patio</u> shall only be provided in accordance with the required <u>setbacks</u> for the <u>principal building</u> as indicated in the <u>zone</u>, except in accordance with the permitted encroachments of this By-law.
  - 3. A <u>seasonal temporary outdoor patio</u> shall be located at <u>grade</u> with direct access from the first <u>storey</u> of a <u>building</u>.
  - 4. A <u>seasonal temporary outdoor patio</u> shall be located between a <u>building</u> and a <u>road</u> and shall not be separated from the main use by any <u>road</u>, <u>lane</u>, <u>aisle</u> or <u>parking area</u>.
  - 5. A <u>seasonal temporary outdoor patio</u> shall not occupy or obstruct any <u>barrier free parking spaces</u>, <u>roads</u>, <u>aisles</u>, <u>loading spaces</u> or vehicular circulation routes for the <u>premises</u>.
  - 6. A <u>seasonal temporary outdoor patio</u> may occupy <u>parking spaces</u> that are not intended for a <u>residential use</u> and are abutting a <u>building</u> which contains a <u>restaurant</u> or <u>banquet hall use</u> to which the <u>seasonal temporary outdoor patio</u> is <u>accessory</u>, and not be separated by <u>aisles</u>, <u>loading spaces</u> or vehicular circulation routes.
  - 7. A <u>seasonal temporary outdoor patio</u> shall not impede pedestrian or vehicular access to the <u>premises</u>.
  - 8. A <u>seasonal temporary outdoor patio</u> shall not impede a minimum 1.5 m

path of travel for pedestrian walkways.

#### Potential Parking Standards

Additional parking shall not be required for a seasonal temporary outdoor patio.

# OR A COMBINATION OF PROVISIONS NOTED BELOW, BUT NOT LIMITED TO

- 10. The total area of the <u>seasonal temporary outdoor patio</u> shall not exceed ##% of the <u>gross floor area</u> of the <u>principal use</u> to which the <u>outdoor patio</u> is <u>accessory</u>.
- 11. A <u>seasonal temporary outdoor patio</u> may occupy no more than # existing <u>parking spaces</u>.
- 12. In a multi-unit <u>building</u>, a <u>seasonal temporary outdoor patio</u> shall not extend beyond the width of the unit where the <u>restaurant</u> or <u>banquet hall</u> <u>use</u> is located.
- f) Replace all reference to "Outdoor Patio" with "Outdoor Patio or Seasonal Temporary Outdoor Patio" in "Table 6-12: Shared Parking Reduction Formula on Weekdays", "Table 6-13: Shared Parking Reduction Formula on Weekends", "Table 8-2: Permitted Uses in the LMU, MMU, HMU, GMU, CMU and EMU Zones", "Table 8-4: Permitted Uses in the KMS, WMS and MMS Zones", "Table 9-2: Permitted Uses in the Commercial Zones", "Table 10-2: Permitted Uses in the Vaughan Metropolitan Centre Zones".
- g) Amending "Table 11-2: Permitted Uses in the Employment Zones" by adding a new row titled "Seasonal Temporary Outdoor Patio" in alphabetical order under the "Specified Accessory Uses" category as follows:

#### SUMMARY TO BY-LAW - 2024

The lands subject to this By-law include all lands within the City of Vaughan, in the Regional Municipality of York, with the exception of lands in the vicinity of Yonge Street and Steeles Avenue, where By-law 1-88 is applicable.

The purpose of this By-law is to permit the use of seasonal temporary outdoor patios for Restaurant and Banquet Hall uses on a seasonal basis.

## BY-LAW

#### **BY-LAW NUMBER XXX-2024**

A By-law to amend By-law 123-2013, as amended by By-law 141-2022, the City of Vaughan's Site Plan Control By-law, to exempt seasonal temporary outdoor patios accessory to Restaurants and Banquet Halls from Site Plan Control.

**WHEREAS** Subsection 41(2) of the *Planning Act* authorizes Council to enact a By-law to establish a Site Plan Control Area;

**AND WHEREAS** the whole of the City of Vaughan has been designated a Site Plan Control Area pursuant to Subsection 41(2) of the *Planning Act*;

**AND WHEREAS** it is deemed appropriate to adopt, by by-law, site development guidelines and rules for processing Site Development Applications;

**AND WHEREAS** The Corporation of the City of Vaughan considers it desirable to provide specific regulatory relief to the placement of "Seasonal Temporary Outdoor Patios" accessory to a "Restaurant" or "Banquet Hall" use;

**AND WHEREAS** it is appropriate to adopt, by by-law, classes of development that may be undertaken without the approval of plans and drawings otherwise required under Subsections 41(4) or (5) of the *Planning Act*;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- That City of Vaughan By-law Number 123-2013, as amended by By-law Number
   141-2022, is hereby amended as follows:
  - a) That the following be added to Section 5 as a class of development that may be undertaken without the approval of plans and drawings as otherwise required under Subsections 41(4) and 41(5) of the *Planning Act*:
    - "b) Seasonal Temporary Outdoor Patios and the expansion of Outdoor Patios, both accessory to Restaurants and Banquet Halls."
