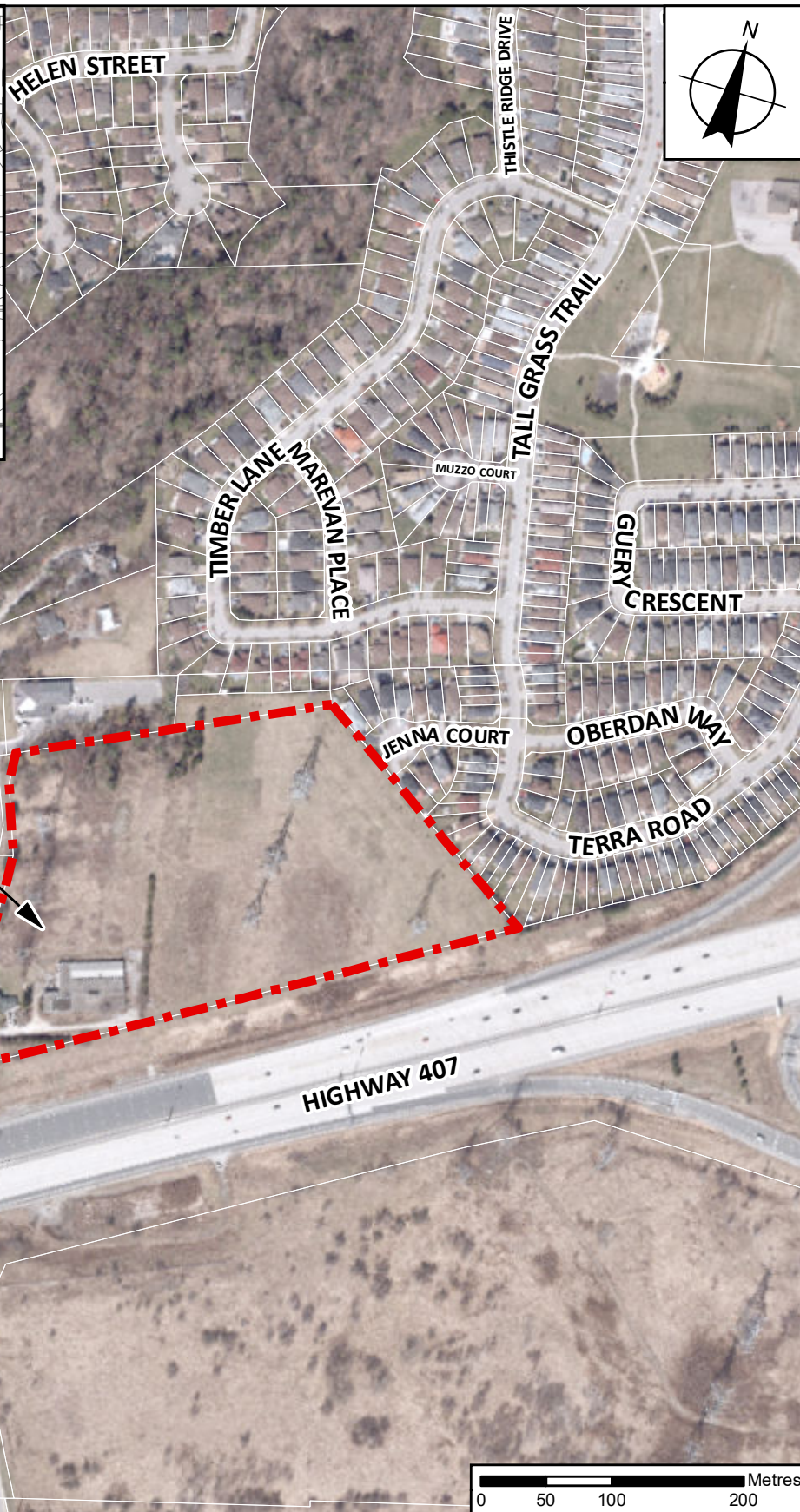
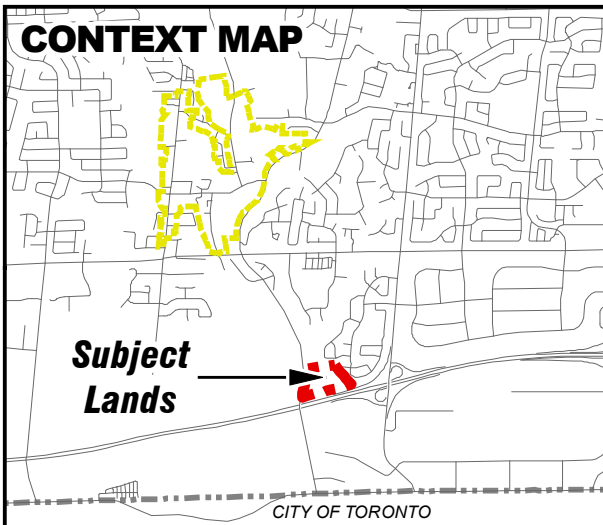

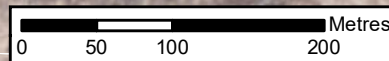
## CONTEXT MAP
