### **Background**

Staff received a letter dated May 28, 2024, from Latif Fazel, CEO, Liberty Development Corporation requesting deferral of the subject matter for reasons contained therein [Attachment 1].

Staff are in the process of assessing and evaluating the implications of Bill 185 (the "Cutting Red Tape to Build More Homes Act, 2024"), specifically as it relates to the removal of the Community Infrastructure and Housing Accelerator (CIHA) tool from the *Planning Act* (Section 34.1). The repeal of Section 34.1 of the *Planning Act* is intended to streamline and create a transparent process for requesting and issuing Minister's Zoning Orders (MZOs).

In view of the above, staff are requesting that consideration of this matter be deferred to the Council meeting of June 28, 2024.

# City of Vaughan By-Law Related Safety Concerns

## Background

- From a City of Vaughan email signature; "RESPECT | ACCOUNTABILITY | DEDICATION"
- From Mayor Del Duca's Proposed 2024 Budget and 2025-2026 Financial Plan, Guiding Principals
  - "Leveraging Efficiencies, Improve Efficiencies, Mitigate Risk"
- As most of you may be aware, for the past 8 plus months, I have been expressing my concerns over enforcement of the City of Vaughans By-Laws, specifically where safety of the public is concerned.
- My concerns are based on actual life experience, either involved or observed in person.
- McKenzie Street is located in the South East corner of Kipling and Highway 7,
  - with a unique entrance to a narrow street at approximately 7 meters in width,
  - no sidewalks so residents are forced to walk on the road, with a speed limit of 50 km/h, 40 km/h after 30 M, or the City Boulevard on the north side of the road,
  - no where for large vehicles to turn around, so they are forced to back out onto Highway 7, or turn around using Private Driveways
  - Parking Permits can NOT be obtained for McKenzie Street for several of these reasons.
- Prior to contacting the City of Vaughan regarding By-Law related matters, I read the applicable By-Law to ensure applicability.

## Parking Enforcement

- Since September 25<sup>th</sup>, 2023 I have been requesting Parking Enforcement for the following offences (many date back as far as July 2019),
- Parking more than .15 M from the limit of the highway, (064-2019, 1 (b))
- Parking within 3 M of a fire hydrant, (064-2019, 8)
- Parking within 9 M of an intersection, (064-2019, 9 (d))
- Parking directly opposite another vehicle where the road is less than 9 M, (064-2019, 9 (m))
- Parking on any portion of the City Boulevard, (064-2019, 9 (q))


As the matter continues as of Monday June 3<sup>rd</sup>, 2024, I have requested the opportunity to have meaningful conversations concerning this with, Supervisor Gibson, Manager Cronsberry, Director Kelly, Deputy City Manager Michaels, Councillor Volpentesta.

On February 29<sup>th</sup>, 2024 the City of Vaughan installed NO PARKING signs for the first approximately 30 M of McKenzie Street from Highway 7.

## Other By-Law Enforcement Requested

- Discharge of Water onto McKenzie Street (in winter months), (231-2011, 5.12 (3))
- Obstructing a Fire Hydrant with fencing and building materials,
- Performing 'Construction activities' during prohibited times without a permit (121-2021, 10.0 (1), (2))

## Encroachment (034-2017, 4 (a), (b), (c), 5 (b))







## Issuance of a Road Cut (Occupancy) Permit

- It was decided that a Road Cut (Occupancy) Permit was issued in response to the Encroachment violation after an order to remove was given,
- The issuance of the Road Cut (Occupancy) Permit was in direct contravention of the Permit Terms and Conditions, General Conditions and related By-Law 294-94,
- Issuance was not an oversight, as I advised numerous staff of inconsistencies prior to issuance of the permit,
- Issuance of the Road Cut (Occupancy) Permit did not mitigate risk to the City,
- I verified with the City Clerks office the validity of the By-Law 294-94,
- Had communications with Eric Vonk, Officer Booth, Supervisor DuFour, 3 people in the City Clerks Office, Manager Cronsberry, Legal Department, Director Suppa, most rationalized this as perfectly acceptable.
- The Encroachment By-Law clearly addresses the specific concern(s),
- I requested on 3 occasions to speak with Mayor Del Duca on this matter,

# THE CITY OF VAUGHAN BY-LAW

### BY-LAW NUMBER 294-94

A By-law to regulate the encumbering of highways during construction or repair and to provide for Road Cut Permits.

WHEREAS Section 210 of the Municipal Act, R.S.O. 1990, C.M. 45, as amended, authorizes the Council to pass by-laws for the purpose of regulating the temporary occupation of highways or portions thereof during the construction or repair of any work thereon.

NOW THEREFORE the Council of the Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- In this by-law,
  - (a) "permit" means a Permit for the Installation/Relocation of Public Utilities and the General Conditions set out on the permit.

### GENERAL ROAD CUT (ROAD OCCUPANCY) PERMIT CONDITIONS

(City of Vaughan By-Law #294-94)

THE APPLICANT FOR THIS PERMIT AGREES TO PROVIDE A MINIMUM OF \$5,000,000 PUBLIC LIABILITY INSURANCE. THE APPLICANT ALSO AGREES AND ACCEPTS FULL RESPONSIBILITY FOR THE PROTECTION OF ALL UTILITIES, PRIVATE PROPERTY AND PERSONS AFFECTED BY THEIR OPERATIONS AND FURTHER AGREES TO INDEMNIFY AND SAVE HARMLESS THE CITY OF VAUGHAN FROM ANY AND ALL DAMAGES OR CLAIMS FOR DAMAGES OR INJURIES OR ACCIDENTS DONE TO OR CAUSED BY THE APPLICANT, OR THE APPLICANT'S EMPLOYEES, AS A RESULT OF THEIR OPERATIONS.

The Applicant agrees to notify the following at least 48 hours prior to commencing work:

Adjacent Property Owners

Bell Canada

Enbridge Gas

Power Stream

Telecommunications Company

- All trenches must be restored as specified herein including drainage ditches, culverts and culvert headwalls. Good drainage must be maintained during the course of operations.
- All utilities must be protected and supported to the satisfaction of the utility concerned.
- In grassed areas adjacent to homes, sodding is required and <u>NEW SOD</u> must be <u>COUNTER SUNK</u> to match existing sod. All areas to receive sod shall have a min. of 100mm of imported screened topsoil.
- Applicant to water and maintain sod until sod is rooted or established.
- Applicant will not store or dump material or equipment on or within municipal right-of-ways.
- 7. Driveways must be repaired in the same manner as the road, specified herein. Property owners and/or residents must receive a min. of 24

## Summary

- Enforce the City of Vaughan By-Laws as written,
- Use the City of Vaughan By-Laws to defend their decisions,
- Have City staff follow the By-Laws themselves,
- By-Laws should be consistent, with each other, and with definitions,
- Future issuance of permits should factor existing restrictions already in place,
- Establish a process and criteria for another department to override another departments decision,
- Establish a process of checks and balances for issuance of Permits.

## Summary

- Address concerns timely and effectively the first time to maximize efficiencies,
- All staff at the City of Vaughan should act in an impartial manner, that does not raise questions about their actions,
- Communicate timely and effectively with residents, businesses, visitors as the case may be,





#### **OUR REQUESTS**

#### 100% privately funded project

- The project will be built over different phases (first new turf field & permanent bubble, then training facility & stadium turf, and then new FIFA approved grass field).
- All maintenance for the facility & fields will be paid by our management company Versus Sports Management & Event (VSME).
- VSME will manage all revenue for the facility (turf / padel rentals, marketing, sales, operations etc.).
- VSME will pay City of Vaughan for the property tax on new building only.
- VSME will donate \$100,000 (in credit) for turf rental time back to the City to be use from Monday-Friday at 9:00am-3:00pm for various school, youth programs, sports activities, summer camps etc.
- Existing youth clubs & teams will have access to rent the turf at the new facility.
- Length of Term: Control of soccer field area/land for 49 years + 49 years.
- Lease land from City for \$1.00/year.
- Existing parking will remain, and we will build a private parking lot for the building with private access to the medical offices, restaurant and padel players.
- Existing & new lighting around the property will be maintained and paid by the city (our facility will pay for its own lighting building only).
- We request the City to continue with all snow removal of roads and public parking lots within the park.
- We request for the City to supply insurance coverage of common public areas of the project.
- We request any power source, water and sewage for the City's assist in delivering this to the site (paid by City).
- We kindly request that the City assist in expediting the permits necessary to get this project done before the 2026
   World Cup so this facility could be used as a training ground for National Teams.
