

Alectra Utilities (formerly PowerStream) has received and reviewed the proposed Variance Application. This review, however, does not imply any approval of the project or plan.

All proposed billboards, signs, and other structures associated with the project or plan must maintain minimum clearances to the existing overhead or underground electrical distribution system as specified by the applicable standards, codes and acts referenced.

In the event that construction commences, and the clearance between any component of the work/structure and the adjacent existing overhead and underground electrical distribution system violates the Occupational Health and Safety Act, the customer will be responsible for 100% of the costs associated with Alectra making the work area safe. All construction work will be required to stop until the safe limits of approach can be established.

Comments:

The Owners are requesting relief to permit an existing accessory structure (gazebo), labeled as 'new pergola' on the submitted sketch, located within the north-west corner of the rear yard with the above-noted variances.

Development Planning Department Staff ('Development Planning Staff') have no objection to the request to permit a reduced interior side yard setback measured to the two west posts (Variance 1) and to the eaves of the gazebo (Variance 3), as well as a reduced rear yard setback measured to the two rear posts (Variance 2). The accessory structure exists in the north-west corner of the rear yard. The north and west sides of the gazebo are screened with wood lattice while the other two sides are open. The gazebo is modest in size does not exceed the maximum lot coverage and maximum height requirements of the Zoning By-law for accessory buildings and structures. The rear of the gazebo faces the interior side yard of the property to the north, 12 Massimo Drive, which maintains a utilitarian rather than yard amenity area.

As such, the gazebo is not anticipated to have adverse use (privacy) or massing impacts on the neighbouring property to the west (66 Condotti Drive) or the property to the north (12 Massimo Drive), and the proposed 0.79 m minimum interior side yard setback provides sufficient space for safe maintenance and access purposes.

Accordingly, Development Planning Staff support the requested variances and are of the opinion that the proposal is minor in nature, maintains the general intent and purpose of the Official Plan and Zoning By-law, and is desirable for the appropriate development of the land.
