TITLE: ADDING PENALTY PROVISION TO THE TREE PROTECTION BY-LAW

**ACTION:** DECISION

**Purpose** 

This report provides a recommendation that would amend the Tree Protection By-law, 052-2018, to provide the City with the authority to issue set fines, pursuant to the *Provincial Offences Act.*, for any offences committed under the Tree Protection By-law.

### **Report Highlights**

 While enacted under the Municipal Act, the Tree Protection By-law is still required to cite section 61 of the Provincial Offences Act to permit the issuance of set fines.

### **Recommendations**

1. Amend By-law 052-2018, as amended, by adding the provision that, "Every person who is convicted of an offence under this By-law is liable to a fine as provided for in the *Provincial Offences Act*, R.S.O. 1990, Chap. P.33."

### **Background**

The City of Vaughan has created set fines for Part I Offences under the *Provincial Offences Act, 1990* ("POA") for multiple by-laws. Set fines allow the City to designate

specific penalty amounts for each offence committed under the by-law, simplifying the issuance of penalties by enforcement staff. In this manner, the By-law and Compliance, Licensing & Permit Services Department (BCLPS) has been creating set fines for any relevant by-laws under its purview, including the Tree Protection By-law.

While the Tree Protection By-law was enacted under the authority of the *Municipal Act,* 2001, including its fine amounts, the City must cite the POA, Section 61, in order to issue such set fines for contraventions of the Tree Protection By-law.

#### **Analysis and Option**

In order for the City to issue set fines for the Tree Protection By-law, it is recommended that the City amend the Tree Protection By-law. Once the Tree Protection By-law is amended, the City will be able to submit its proposed set fines to the Attorney General of Ontario for approval.

### Financial Impact

The approval of the recommendation of this report will enable the City to issue penalties under the POA, however the volume of penalties is at this time unknown.

#### **Broader Regional Impacts/Considerations**

The proposed recommendation will enable staff to better enforce regulations to protect trees, supporting better tree canopy protection throughout the Regional Municipality of York.

### **Conclusion**

The recommendation of this report, if approved, will allow the City to use short form wordings for offences under the Tree Protection By-law and to issue set fines, pursuant to the POA.
