## **Development Planning:**

Official Plan: Vaughan Official Plan 2010 ('VOP 2010'): "Low-Rise Residential" and "Natural Area"

The owner is requesting permission to permit a maximum lot coverage of 18.95% for the proposed single detached dwelling, building height of 12.95m for the proposed single detached dwelling, and maximum driveway width of 16.76m.

A site visit was conducted by Development Planning Staff on July 9, 2019. An arborist report was submitted on March 27, 2019 and prepared by Baker Turner Inc. A second revision, which incorporated several comments, was submitted to the satisfaction of the Urban Design Department on June 27, 2019.

The Development Planning Department is of the opinion that the proposal is minor in nature, maintains the general intent and purpose of the Official Plan and Zoning By-law, and is desirable for the appropriate development of the land.

# Cultural Heritage (Urban Design):

The subject property is not designated under the Ontario Heritage Act, is not included in the Register of Property of Cultural Heritage Value and is not noted as a property of interest to Cultural Heritage Division, as per the City of Vaughan Heritage Inventory. Therefore, there are no cultural heritage concerns regarding the subject property.

The subject property lies in an area identified as a being of high archaeological potential in the City's database of archaeological resources. An archaeological assessment will not be required; however, the owner is advised that standard clauses apply:

- i. Should archaeological resources be found on the property during construction activities, all work must cease and both the Ontario Ministry of Tourism, Culture and Sport, the City of Vaughan's Policy Planning and Urban Design and Recreation and Culture Departments shall be notified immediately.
- ii. In the event that human remains are encountered during construction activities, the proponent must immediately cease all construction activities and shall contact the York Regional Police Department, the Regional Coroner and the Registrar of Cemeteries at the Ministry of Consumer Services.

# **Development Engineering:**

The Development Engineering (DE) Department does not object to variance application A224/18 subject to the following condition(s):

- 1) The owner/applicant shall submit the final Lot Grading and/or Servicing Plan to the Development Inspection and Lot Grading division of the City's Development Engineering Department for final lot grading and/or servicing approval prior to any work being undertaken on the property. Please note, that architectural design features (i.e. window placement), that do not impact the style of roof approved by the Committee, are not regulated by this decision.





















AREA CALCULATIONS N.T.S.




BASEMENT AREA: 12, 066 S.F.




GROUND FLOOR AREA: 7,585 S.F.

THIRD FLOOR AREA: 508 S.F.












SECOND FLOOR PLAN SCALE: 1:300



REAR ELEVATION SCALE: 1:200


