





Official Plan:

Vaughan Official Plan 2010 ('VOP 2010'): "Low-Rise Residential"

Comments:

The Owner is seeking relief to permit a new single detached dwelling, rear yard cabana, and outdoor swimming pool with the above-noted variances.

The Development and Parks Planning Department has no objections to Variance 1. New dwellings in established neighbourhoods "(EN)" that exceed 9.5 m in height are required to have minimum interior side yard setbacks that are the greater of that of the applicable zone, the existing side yard, or 2.2 m. Therefore, the variance is required to reduce the existing west interior side yard from 27.13 m to 8.2 m. The intent of the established neighbourhood "(EN)" provision is to ensure that new dwellings are consistent with the established built form characteristics. The intent of the side yard setback provision is to maintain space for access and stormwater management. The requested variance meets the built form characteristics of the established neighborhood and maintains the general intent of the Zoning By-law.

The Development and Parks Planning Department has no objections to Variance 2 to increase the maximum permitted height from 8.5 m to 9.91 m. The owners propose a variety of trees and hedgerow around the property to screen the flat-roofed dwelling from the westerly neighbour and the public realm. As such, the proposed height increase is not anticipated to incur any negative privacy or massing impacts, and is considered minor in nature.

The Development and Parks Planning Department has no objections to Variance 3 to increase the maximum permitted driveway width from 9 m to 10.28 m. The cumulative width of the proposed circular driveway measured at the lot line is approximately 9.14 m and is 10.28 m measured at its widest point. The driveway is proposed to be screened by plant beds and trees, and is not anticipated to incur negative impacts on the streetscape.

The Development and Parks Planning Department has no objections to Variance 4 to permit the outdoor swimming pool to not be fully permitted in the rear yard. The rear yard as defined per Zoning By-law 001-2021 is located between the rear lot line and the nearest part of the dwelling. The northern portion of the pool closest to the dwelling is not located

within the rear yard and is not located in any other yard. As such, the proposed pool variance is minor in nature and meets the general intent of the Zoning By-law.

The Development and Parks Planning Department has no objections to Variance 4 to increase the cabana height from 3.0 m to 4.63 m. The hip-roofed cabana has a modest mass and complies with maximum lot coverage provisions. The proposed cabana is adequately setback from the east and south lot lines and is not anticipated to pose massing impacts. A variety of vegetation including trees and hedges are proposed along the east and south lot lines to screen the cabana.

Accordingly, the Development and Parks Planning Department supports the requested variances and is of the opinion that the proposal is minor in nature, maintains the general intent and purpose of the Official Plan and Zoning By-law, and is desirable for the appropriate development of the land.

Recommendation:

The Development and Parks Planning Department recommends approval of the application.
