17. ACCESSIBILITY ADVISORY COMMITTEE - VACANCY

ACTION: DECISION

Purpose

To inform Council of the vacancy created in the Accessibility Advisory Committee and to seek direction with respect to filling the vacancy.

Report Highlights

- A member has resigned from the Accessibility Advisory Committee.
- As per the Terms of Reference, a majority of the members of the committee shall be persons with disabilities, as required by the *Accessibility for Ontarians with Disabilities Act* (AODA).
- Direction is required with respect to filling the vacancy.

Recommendations

1. That the resignation of Ms. Nida Khurshid, be received; and
2. That Council directs staff to initiate the recruitment process to fill the vacancy.

Background

The vacancy was due to a resignation. The Office of the City Clerk received an email from Nida Khurshid indicating her intention to resign from her Council-appointed position on the Accessibility Advisory Committee.

The Chair was advised of the resignation and the requirement under the AODA and that a report was being brought forward for Council's consideration.

Analysis and Options

The Terms of Reference provides that the Accessibility Advisory Committee shall be composed of one (1) Member of Council and nine (9) citizen members. A majority of the members of the committee shall be persons with disabilities, as defined by the AODA, and should reflect the diversity of the City's population. Members are appointed by Council and any changes to the membership will require Council approval.

Due to the legislative requirements regarding the committee membership, staff is proposing to initiate the recruitment process to fill the vacancy. The Office of the City Clerk will report back with the applications once the recruitment process is completed.

Financial Impact

No new funds are required as the operational expenses are covered within the Office of the City Clerk's budget.

Conclusion
