*BY-LAW*

**BY-LAW NUMBER 090-2025**

**A By-law to amend the Consolidated Traffic By-law 284-94, as amended, to govern and control traffic in the City of Vaughan.**

**WHEREAS** By-law 284-94 of The Corporation of the City of Vaughan, as amended, regulates traffic on roads under the jurisdiction of the City of Vaughan;

**AND WHEREAS** amending by-laws may be enacted from time to time by the Council of The Corporation of the City of Vaughan, changing the traffic regulations on roads under its jurisdiction;

**AND WHEREAS** the Council of the Corporation of the City of Vaughan deems it appropriate to further amend Traffic By-law 284-94, as amended;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT City of Vaughan By-law 284-94, as amended, be further amended by adding the following provisions to Schedule “E”, Part 1:

SPEED LIMIT	STREET	DESCRIPTION
40 km/h	The Boulevard	East limit of Highway 27 to the easterly limit of the street
40 km/h	Mattucci Court	East limit of Weston Road to the easterly limit of the street
40 km/h	James Street	North limit of Woodbridge Avenue to the northerly limit of the street
40 km/h	William Street	East limit of Kipling Avenue to the easterly limit of the street
40 km/h	Waymar Heights Boulevard	North limit of Davidson Drive to the south limit of Gamble Street
40 km/h	Blue Willow Drive	East limit of Ansley Grove Road to the west limit of Matthew Drive
40 km/h	Blue Willow Drive	East limit of Michelle Drive to the west limit of Weston Road
40 km/h	Fieldstone Drive	South limit of Blue Willow Drive to the west limit of Weston Road

40 km/h	Royal Appian Crescent	West limit of Confederation Parkway (north intersection) to the West limit of Confederation Parkway (south intersection)
40 km/h	Novella Road	East limit of Confederation Parkway to the west limit of Grand Trunk Avenue
40 km/h	Belvia Drive	East limit of Confederation Parkway to the west limit of Grand Trunk Avenue
40 km/h	Tuscana Boulevard	East limit of Confederation Parkway to the west limit of Grand Trunk Avenue
40 km/h	Cherry Hills Road	North limit of Glen Shields Avenue (west intersection) to the north limit of Glen Shields Avenue (east intersection)
40 km/h	Quaker Ridge Road	East limit of Glen Shields Avenue to the west limit of Point O'Woods Drive
40 km/h	Point O'Woods Drive	East limit of Glen Shields Avenue to the north limit of Quaker Ridge Road

2. THAT City of Vaughan By-law 284-94 as amended, be further amended by adding the following provisions to Schedule “E”, Part 7 – Speed Limit By-law – Neighbourhood Area 40 Km/h:

NEIGHBOURING BOUNDARIES	SPEED LIMIT
Kirby Road (north) Dufferin Street (east) Teston Road (south) Keele Street (west)	40 km/h
Rutherford Road (north) Clarence Street (east) Langstaff Road (south) Highway 27 (west)	40 km/h
Major Mackenzie Drive (north) Jane Street (east) Rutherford Road (south) Weston Road (west)	40 km/h
Teston Road (north) Bathurst Street (east) Major Mackenzie Drive (south) Dufferin Street (west)	40 km/h
Highway 7 (north) Bathurst Street (east) Centre Street (south) Dufferin Street (west)	40 km/h, excluding Racco Parkway and Caraway Drive

3. THAT City of Vaughan By-law 284-94, as amended, be further amended by adding the following provisions to Schedule “G”, Part 3 – Community Safety Zones;

STREET	FROM	TO
Ahmadiyya Avenue	The east limit of Mahmood Crescent (west intersection)	The west limit of Tahir Street
Valley Vista Drive	The east limit of Thomas Cook Avenue	The west limit of Big Rock Drive / Chaya Sara Gardens
