Schedule 2 – Natural Heritage Network

This schedule identifies a core feature within the Carrville District Centre at the northwest corner of Rutherford Road and Dufferin Street surrounded by a pink area "Top Be Determined Through Future Studies." This designation should be removed as it does not reflect that the limits of this feature have already been studied and determined through draft plan of subdivision 19T-12V009 and the subsequent registration of the first phase of development. Please see the enclosed highlighted schedule identifying the core feature in question.

Schedules 9A & 9B – Street Classification & Street Type

Main Street within Carrville District Centre Block 18 has been identified as a 24m Minor Collector, however, the secondary plan identifies this as a 23m Minor Collector through policy 11.2.18.2c. Please correct Schedules 9A & 9B to match the secondary plan. Please see the enclosed highlighted schedule identifying the street in question.
