*BY-LAW*

**BY-LAW NUMBER 141-2025**

A By-law to amend the Administrative Penalties By-law 240-2024, as amended, to align it with City policies, add the Parks By-law 134-95, as amended, to the list of designated by-laws, update wording with respect to a fee charged for hearings, and to update by-law and section numbers for by-laws under which administrative penalties may be issued.

**WHEREAS** the City has Administrative Penalties By-law 240-2024 (“Administrative Penalties By-law”), which lists by-laws under which administrative penalties may be issued, along with the sections in those by-laws that reference the Administrative Penalties By-law;

**AND WHEREAS** some of the by-law and section numbers need to be updated and corrected, and other sections amended to align with City policies and other City by-laws;

**AND WHEREAS** the Council of the City of Vaughan consider it desirable for the City’s by-laws to have the most up to date and correct references;

**NOW THEREFORE** the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

- 1. That Administrative Penalties By-law 240-2024, as amended, be further amended by deleting and replacing section 5.0(1)(e) with, “A *Contravener* may request a review of the *Screening Officer’s* decision by a *Hearing Officer*, for which a fee may be payable in accordance with the *Fees and Charges By-law*.”.
- 2. That Administrative Penalties By-law 240-2024, as amended, be further amended by deleting and replacing section 5.0(5) with, “If the *Contravener* fails to attend any stage of an *Appeal*, a decision may be made in the *Contravener’s* absence and, subject to section 5.0(6), a *Failure to Attend Fee* will be imposed.”.
- 3. That the table in Schedule 1 – Designated By-laws of the Administrative Penalties By-law 240-2024, as amended, be deleted and replaced with the following table:
