**Purpose**

To seek Council approval of the Development Charges Background Study for the Teston Road East and West Sanitary Sewer Service Area, and final staff recommendations related to the enactment of the area specific development charges by-laws for these works.

**Report Highlights**

- Seeking approval of the Development Charges Background Study for the Teston Road East and West Sanitary Sewer Area as well as the two associated by-laws.
- Extensive consultation has occurred with the impacted landowners to determine the final draft rates being presented.

**Recommendations**

1. That the Development Charges Background Study for the Teston Road East and West Sanitary Sewer Service Area (Attachment 1) be approved;
2. That the Teston Road East Sanitary Sewer By-law (Attachment 2) be approved;
3. That the Teston Road West Sanitary Sewer Infrastructure By-law (Attachment 3) be approved;

4. That the capital forecast to 2041 for the Teston Road East and West Sanitary Sewer Infrastructure included in the Development Charges Background Study, dated March 3, 2025, and subject to maintenance of service levels, the availability of funding and Council policies, be adopted;
5. That Council commit to future operating costs associated with the capital forecast contained in the Development Charges Background Study, to be addressed through future budget cycles; and
6. That Council confirm that no further public meetings pursuant to the *Development Charges Act, 1997* are required prior to the enactment of the new Area specific development charges By-laws.

### **Background**

In 2020, the City initiated the City-Wide Integrated Urban Water Plan to support projected growth to 2051. This plan was finalized in September 2024 and includes a comprehensive listing of capital expenditure requirements for new and expanded water, wastewater and stormwater infrastructure. As a part of this work, the Teston Road East and Teston Road West Sanitary Infrastructure were identified as infrastructure that would be required in the short term in order to increase capacity in the area and facilitate development in Block 27, 28, 34, 35, 41, 42 and 49.

As development has already begun to occur in the area where the infrastructure is required, it was determined that an Area Specific Development Charges Study should be undertaken for both Teston Road East and Teston Road West as soon as possible, to establish area specific development charge rates, to allow the City to maximize the Area specific development charges collections from the benefiting landowners. The total cost of the works for Teston Road West Sanitary Sewer Works is approximately \$85.1 million and approximately \$31.8 million for Teston Road East Sanitary Sewer. These costs, benefiting land areas, and draft area specific development charge rates were further refined through the ongoing area specific development charges consultation process.

### ***Communications Strategy***

A kick-off meeting took place with the development industry regarding the Teston Road East and West Sanitary Infrastructure on Aug. 14, 2024, where the draft rates and benefiting map areas were presented. A second and third meeting were held on Aug. 29, 2024 and Sept. 17, 2024 to discuss the technical aspects of the study. A public statutory meeting was held on Oct. 8, 2024 which was advertised in accordance with the *Development Charges Act, 1997*. Further meetings since the public meeting have been held with the impacted landowners to address site specific concerns. The Development Charges Background Study and associated rates included within this report are the cumulative result of those discussions that took place.

## **Analysis and Options**

The Teston Road East and West Sanitary Infrastructure was identified as infrastructure required to support growth as a part of the City-Wide Integrated Urban Water Plan, with the full build out of the benefiting lands anticipated between 2041 and 2046.

The Teston Road East Sanitary Infrastructure includes a sanitary sewer that runs along Teston Road from Jane Street to Keele Street and sanitary sewer oversizing in Block 27.

The Teston Road West Sanitary Sewer Infrastructure includes sanitary sewers and force mains on Teston Road between Weston Road and Jane Street and on Weston Road north of Teston, as well as a sewage pumping station. This infrastructure has been sized appropriately to support the anticipated development in the area to full build out in accordance with the City-Wide Integrated Urban Water Plan. The Teston Road Sanitary Sewer Infrastructure works will connect to York Region's future Jane Street sanitary trunk sewer at Teston Road and Jane Street. The expected completion date for the Region's infrastructure is quarter four of 2028.

Timing for the works is somewhat unclear due to the linkages between the requirements for the works and the advancement of development in the area. The details around the construction will become more certain as development applications progress. It is important for the City to ensure that an area specific development charge is in place to begin collections for the infrastructure in advance, particularly due to the development charge freeze provisions recently added to the *Development Charges Act, 1997* that allow a development to freeze its development charges at an earlier time in the development process. Advancing the area specific development charges at this time ensures that all benefiting parties will contribute to the works.

Although discussions with the impacted landowners is ongoing, it is anticipated that the City will undertake the construction of much of the works. To support these costs a new area specific development charge is being proposed to fund both the capital and borrowing costs to the City associated with emplacing the required infrastructure in the area.

## **Financial Impact**

***The area specific development charges have been adjusted as an outcome of the consultation with the development industry.***

A public statutory meeting was held on Oct. 8<sup>th</sup> where the draft area specific development charge rates for Teston Road West and Teston Road East Sanitary Sewer Infrastructure were presented to the public. At that time there were four rates and benefiting map areas identified for Teston Road West, to be charged on a per hectare basis as outlined below:

Within Teston Road East, there was one area specific development charges rate and benefiting map area identified as follows:

Since the public statutory meeting, there has been ongoing discussion with the impacted landowners which has resulted in a series of changes to the area specific development charges that were presented last year.

### ***Adjustments to the Teston Road East Sanitary Improvement area specific development charges***


The Teston Road East Sanitary Sewer – Map 1 sanitary sewer to run along Teston Road from Jane Street to Keele Street has had the sizing and costing adjusted based on feedback from the industry. This resulted in an increase to the net cost of approximately \$3.5 million.

A second benefiting map area was added to the Teston Road East Area specific development charges to capture a recovery for Block 27 oversizing works that will be undertaken. The development charges eligible costs for this work are approximately \$700K and would be applicable to Block 28 landowners.

The changes outlined above have resulted in a total estimated cost for Teston Road East Sanitary Infrastructure of approximately \$31.8 million and is outlined below.


### Teston Road East Sanitary Sewer Service Area

The map below represents the service area for the Teston Road East Sanitary Sewer Service area for illustration purposes but does not reflect the specific areas where area-specific charges apply. Maps 1 and 2 below illustrate where area specific development charges apply.




**Map 1: Teston Road East Sanitary Sewer – Jane Street to Keele Street**

This includes a sewer along Teston Road from Jane Street to Keele Street. The total cost is estimated at \$31.1 million, with a net benefiting area of 443.55 hectares. The benefiting map area includes the following lands:



**Map 2: Teston Road East Sanitary Sewer – Block 27 Oversizing**

This includes a recovery for Block 27 sanitary sewer oversized works. The total cost estimate for the work is \$700K, with a net benefiting area of 180.99 hectares. The benefiting map area includes the following lands:



This results in two per hectare rates as follows:

***Adjustments to the Teston Road West Sanitary Improvement area specific development charges***

The Teston Road West Sanitary Infrastructure – Map 1 and Map 2 net developable areas have been reduced through the removal of 45.3 hectares in response to discussions with the development industry regarding existing infrastructure that those lands currently tie into in the area.


The Teston Road West Sanitary Infrastructure – Map 2 sanitary sewer that runs along Weston Road was adjusted and has been updated to terminate at Phillips Lane, north of Teston Road, this has resulted in an overall net cost reduction of approximately \$10.1 million. Although the section of sewer north of Phillips Lane is required, staff have removed this portion of the cost from the area specific development charge until further consultation with the front-ending landowners can be undertaken and revised costing can be determined. This area specific development charge will be updated along with the City-Wide Development Charges Update, which is planned for approval in quarter two of 2026, at which time these additional costs will be added.

Teston Road West Sanitary Infrastructure – Maps 3 & 4 with servicing for lands north of Kirby Road have been removed from the updated Area Specific Development Charge Study at this time because of the changes to Map 2 and its impact to Map 3 & 4 benefiting areas and costs. Although these works are still required to service the lands it has been excluded at this time but will be added to the area specific development charge in a future update that will coincide with the City-Wide Development Charges Study Update, with approval expected in quarter two of 2026. This will allow for additional time to determine the costing and benefiting areas for Map 2, 3 and 4.

Further oversizing has been identified to be included in the area but because City staff have not received the supporting costing from the landowners to date, and time is required to review these costs in order to incorporate them accurately into the study, it has been excluded at this time. City Staff have committed to adding these oversizing costs to the area specific development charge in a future update that will coincide with the City-Wide Development Charges Study Update, with approval expected in quarter two of 2026.

The changes outlined above have resulted in a total estimated cost for Teston Road Sanitary Infrastructure of approximately \$85.1 million and is outlined below.


The Teston Road West Sanitary Infrastructure costs are divided into four benefiting map areas which are made up of a combination of four service areas determined by whose is benefiting from the infrastructure. The service areas are as follows:



Each map comprises a benefiting area for portions of the infrastructure with some of the benefiting map areas overlapping where lands benefit from more than one component of the overall infrastructure. This results in two benefiting map areas, with the understanding that two further benefiting map areas will be forthcoming as a part of a future area specific development charges update. The two benefiting map areas included in the Teston Road West Sanitary Sewer area specific development charges are as follows:


**Map 1: Teston Road West Sanitary Sewer Infrastructure – Segment A: Teston Road Sanitary Sewer**

This includes a sewer that runs from Shipwell Street/Mosque Gate to Jane Street. Map 1 benefits all four of the service areas described above. The estimated cost of the works is \$4.4 million with a benefiting area of 1,113.67 hectares including the following lands:



**Map 2: Teston Road West Sanitary Sewer Infrastructure – Segment B: Weston/Teston Rd Sewer and Pumping Station**

This includes a sewer that runs along Weston Road from Teston Road to Philips Lane, and on Teston Road from Kirby Road to Shipwell Street/Mosque Gate as well as a sewage pumping station. Map 2 benefits services areas 2, 3 and 4 as described above. The estimated cost of the works is \$80.7 million with a benefiting area of 681.19 hectares including the following lands:



This results in two per hectare rates as follows:

### **Operational Impact**

Funds required to operate and maintain the infrastructure will be generated through the utility rates and any additional operating costs triggered by the capital program will be included within those rates.

### **Broader Regional Impacts/Considerations**

The Teston Road East and West Sanitary Sewer Infrastructure works will outlet to York Region’s future Jane Street sanitary trunk sewer at Teston Road and Jane Street. As part of York Region’s Northeast Vaughan Wastewater Trunk sewer works, the Region’s Jane Street trunk sewer is expected to be in service by quarter four of 2028.

### **Conclusion**

Completion of the Teston Road East and West Sanitary Sewer Works is vital in ensuring that the infrastructure that is required to support growth is undertaken in alignment with anticipated development. The proposed area Specific Development Charges Background Study and By-laws will ensure that the funding is in place to support the construction of this infrastructure in such a way as growth pays for growth.
