NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

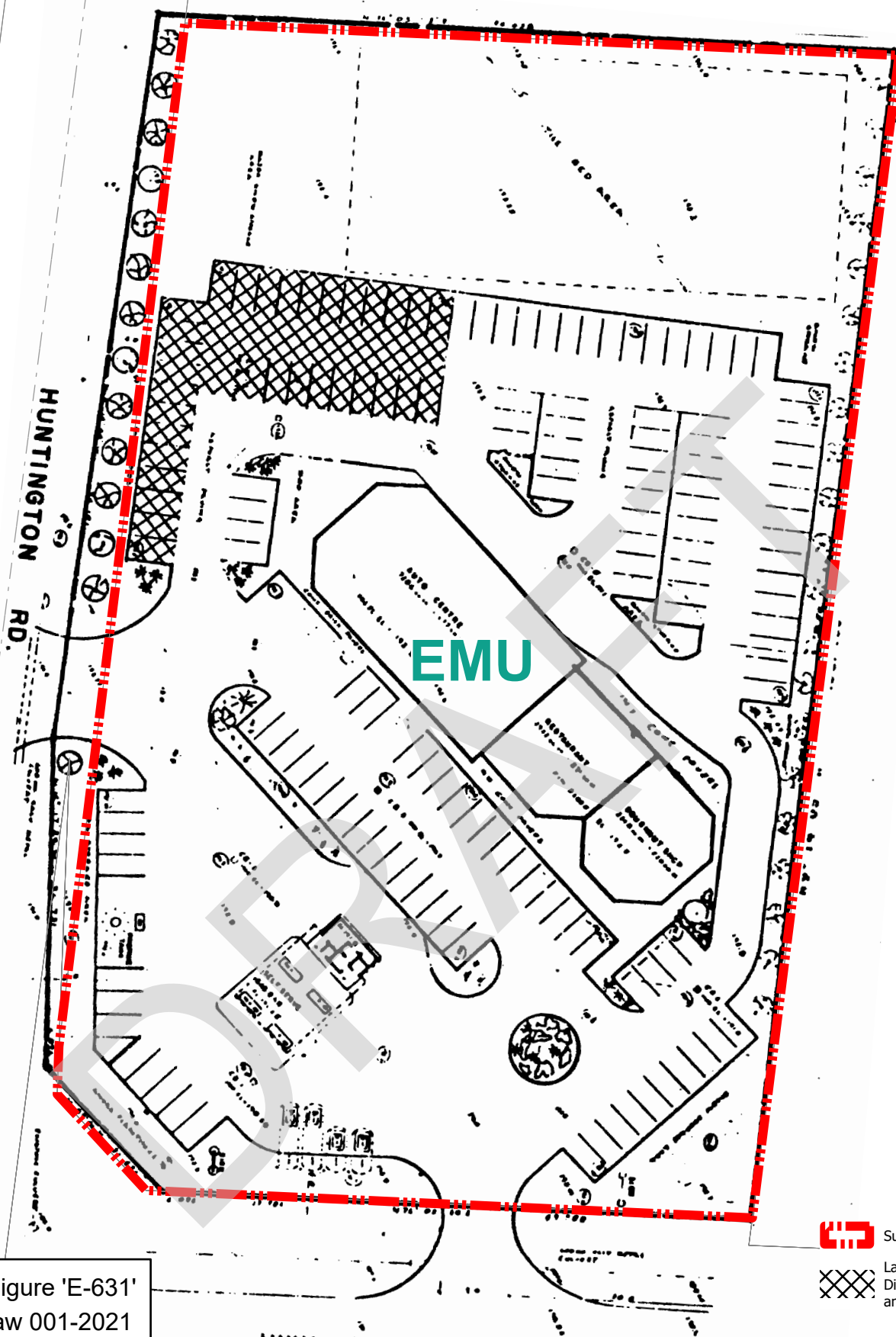
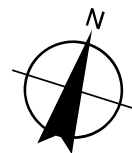
1. That City of Vaughan By-law Number 001-2021, as amended, be and it is hereby further amended by:

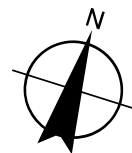

SUMMARY TO BY-LAW 069-2026

The lands subject to this By-law are located on the northeast corner of Highway 7, and Huntington Road, municipally known as 6720 Highway 7, City of Vaughan, Regional Municipality of York.

The purpose of this By-law is to amend City of Vaughan Zoning By-law 001-2021 by adding a label to Figure E-631 in Exception 14.337 that identifies the purpose of the cross-hatched area identified for the outside storage and display of motor homes and automobiles, which was previously labelled in By-law 59-87, which amended Zoning By-law 2523.

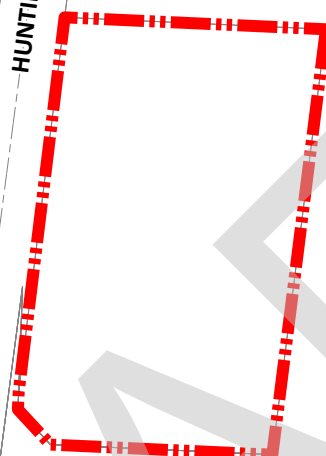


HIGHWAY 50

HUNTINGTON ROAD

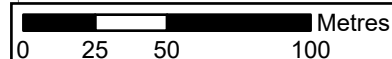
