

Thank you for your e-mail.



Legalization of Recreational Cannabis

On October 17th we saw recreational cannabis being legalized in Canada and Ontario now allows on-line purchases, however on April 1st we will be seeing private retail stores begin to sell cannabis. Leading up to this time the province has provided the municipalities with a one-time window to opt out of retail sales.

The Kleinburg & Area Ratepayers' Association is opposed to this initiative being spearheaded by the federal/provincial governments. We feel that the 150M distance for the property line for a public or private school is not adequate, the hours of the retail stores are not reflective of regular store hours and will incur added security and staff training requirements. Also noted is the fact that municipalities have a limited authority to pass by-laws to further restrict the locations where cannabis can be used which could be a stumbling block when trying to reign in the areas available for smoking cannabis, and also cigarette.

It is for the reasons above, that our Association is opposed to allowing retail stores to sell cannabis in the Region of Vaughan.





Mayor Bevilacqua and Council Members,

My name is Furio Liberatore and I am a life long resident of Vaughan. I wish to express my strong concerns regarding retail cannabis in our City and why I feel that the City of Vaughan should opt out. There are too many unknowns and too many unanswered questions at this point in time to make a sound decision.

Some important questions that need to be answered are:

Do we know the total costs that the City of Vaughan will incur to manage, educate, and enforce cannabis related issues?

Who will decide where these retail stores will be located?

Is there a limit to how many stores will be granted?

Will the City of Vaughan have the authority to limit how many stores will be able to operate?

Does the City of Vaughan have the authority to increase the 150 m restriction on schools?

Will the City Of Vaughan have the opportunity to review the applicant/application for each retail store?

How much money will the province give the City of Vaughan if we opt in?

Will that amount of money offset the cost that they city will incur?

How far can one smoke cannabis from a school?

How will private properties backing onto schools that consume cannabis be dealt with?

Once a notice of application is posted for retail with a public objection, will the City of Vaughan be an arbitrator to the application?

What is the City of Vaughan's plan to limit points of retail?

If the City's answer is "no, or I don't know" to any of these questions, you must vote to opt out! There is too much at stake here to simply be complacent on this matter!

With neighbouring municipalities such as Richmond Hill, Mississauga, Georgina, Markham, and Milton opting out, Vaughan can expect a large number cannabis consumers to come to here to make purchases. This will bring more safety concerns and unwanted traffic to our beautiful City. Given the nature of the product being sold at these retail locations, due diligence to our health and safety must be paramount when making this decision.

This one time option to opt in or out is forcing our city to make a rash decision with too many unknowns. I am writing to you today backed with a online petition of Vaughan Residents of over 550 signatures.

A decision should not be made based on the amount of revenue that this will bring to our city, but made on our City's core values and the type of reputation we wish to portray. 

The use of cannabis, marijuana, pot, weed – whatever you want to call it – it's sole purpose is to get people high. This is unlike alcohol, which pot-pushers try to use as a comparison. Alcohol is part of a gastronomical or culinary experience when consumed responsibly and as it was intended.

So what does it mean to 'get high'? In other words, it is an alternate state of mind – one that differs from our natural state. It is a form of intoxication immediately upon it's consumption.

Despite the appalling, grossly irresponsible decision by our federal government to legalize it's use, which conversely would now render the law against public intoxication invalid simply by contradiction, I still believe we can overcome this battle by municipalities banning these types of establishments from operating in their areas.

At present, I am ashamed to refer to myself as Canadian. To see images of the maple leaf on the Canadian flag replaced with a marijuana leaf; To hear the lyrics of the national anthem being sung as "oh cannabis"; To hear the leader of the country, the prime minister of a nation, sadly - this nation, boast on a radio ad about 'helping Canadians get high'; Having to see signs at the airport reminding Canadians that Cannabis is illegal nearly everywhere else in the world; Disgusted with Canadian publications setting out a plethora of 'weed infused' menu items that will be available upon legalization — including things like edibles -namely psychedelics and hallucinogenics; That's correct the Liberal gov't led by Justin Trudeau have stamped their approval — by way of legalization — on the citizens of this country ingesting psychedelic and hallucinogenic inducing drugs.

The purpose of a government is to 'govern' the people. This means to set out laws that protect the citizens, keep them safe and to promote the common good. I don't believe anyone will claim this government fulfilled this obligation or duty when — due to it's legalization — they are faced with someone experiencing a psychotic episode or some form of hallucination, either face to face or while operating a vehicle.

Furthermore, I have great concern for our police officers who are tasked with the burden of having to deal with these people when they become unruly, irrational and are quite literally 'out of their minds'. I have also been told by ER nurses that they have many patients who come to the ER due to the ill effects of marijuana use. An excerpt from the National Institute of Drug Abuse website states "Pleasant experiences with marijuana are by no means universal. ...some people experience anxiety, distrust or panic. People who have taken large doses of marijuana may experience an acute psychosis, which includes hallucinations, delusions and a loss of the sense of personal identity." I don't think we need to look much further than our friends south of the border, whereby many of the tragedies resulting in the loss of many lives were at the hands of marijuana users.

Because I anticipate someone addressing the supposed medicinal benefits of marijuana, and it being all natural, to them I say it is another debate for another time. But in the interim, I suggest they research the Health Canada website, specifically the Serious Warnings and Precautions, as well as research THC, especially the continuously increasing levels and with that I leave them with the question of "How and why is that happening?"

There needs to be a reality check – where there used to be the odd user, who somehow knew of a dealer and hid in their basement, garage or shed to smoke up– you will now have many more users. They are going to "try getting high" because "why not?" there is nothing stopping them and they can

easily access it. This will lead to more altercations involving police, more visits to the ER, more vehicular fatalities and more drug addictions, especially among teens.

The legalization is nothing to be proud of. It's a disgrace, an embarrassment and utterly shameful. Nearly the entire world recognizes and understands why marijuana should be illegal, what happened to Canada?

This brings me to my final and most important point, a reminder of the One whom we should always consider at the forefront of every decision we make - our God and Creator. How gravely offensive it must be to our Loving Father in Heaven who granted us with the greatest gift – life itself. 
We are writing to you today regarding the current debates and vote on allowing cannabis sales in the City of Vaughan. Along with the majority of Vaughan residents, the **Ahmadiyya Muslim Jama'at is against the opening of cannabis stores within our boundaries.**

The Ahmadiyya Muslim Jama'at would formally like to request the councillors of our wonderful City of Vaughan to opt-out of cannabis stores. There are many variables in play, and as our representatives we would implore you to safeguard our rights and to ensure that the people of Vaughan are safe.

There are many threats that are posed if the City chooses to opt-in. We would like to point out three reasons as to why the City of Vaughan should opt-out. The first concern is in respect to locations. There needs to be more control on the number of stores and their locations due to the increased risk of exposure to children and youth. Municipalities, like Vaughan will have little to no say on where these cannabis stores will be located. The 150m minimum distance rule from schools is not enough. Additionally, Cannabis stores are simply not the same as other stores and it's unfitting to assume otherwise. Municipalities need to be able to restrict and allow with more precision based on local realities.

Second, the opening of cannabis stores does not match Vaughan's Vision 2020: to develop a vibrant, attractive, livable downtown core. Potentially, it will create a downtown centre (and hence an extended Vaughan City) that would push people and businesses away. Vaughan has one of the highest Socio-Economic scores in the country all while allowing family and faith values to flourish. Cannabis stores would go against our collective values. Vaughan simply does not have the social acceptance of cannabis use that cities like Toronto have. We feel through our interaction with Vaughan residents, that we collectively as residents are more concerned with creating a family-safe environment for all.









Third, there are still many unknowns so we must proceed with caution. As Mayor Crombie from Mississauga said, "We only get one chance to get this right." Many other municipalities who have similar socio-economic and social values as Vaughan have, have opted-out including: The Township of King, East Gwillimbury, Mississauga, Markham, Pickering, Richmond Hill, Tecumseh, and Wasaga Beach. In fact, 62 Municipalities to date have opted out and we believe that fact alone is a strong message. The points that are still unclear (due to a lack of time studying these issues) are the tax benefits vs social harm, and or the ability to receive extra funding from the Province regardless of opting in or not, various alternatives, the societal acceptance of simply travelling to Toronto to get their fix, and many others. Again, the motivation of the Federal Government to rush this legislation through should not constitute us as a society to simply also rush our acceptance of it.

Again, the Ahmadiyya Muslim Jama'at would appeal to you as our representatives to safeguard the livelihood and safety of the residents of Vaughan. Thank you for your time and consideration. We have faith that our representatives will make the right decision and look out for the interests of the people they serve. As always, myself and the community are available to discuss this matter further.



Today's Decision

The purpose of this Special Committee of the Whole Meeting:

- To receive input from the residents of Vaughan; and,
- For City Council to pass a resolution on
 - Whether to permit provincially licensed retail cannabis stores in Vaughan; and,
 - If not, provide direction to staff to notify the Province of the City's decision to opt out of the province's retail model.

NOTE: Issues relating to where cannabis may be consumed will be addressed at a later date.



Background

- Staff became engaged in review of cannabis legalization in November of 2017.
- Regional Working Group was established to share and leverage information.
- Internal City of Vaughan Cannabis Working Group was formed to co-ordinate municipal policy efforts. Departments include:
 - Legal, Planning, Building Standards, Recreation, Corporate and Strategic Communications, Economic & Cultural Development, Vaughan Fire & Rescue and Finance.
- Ongoing consultation with external partners, including YRP, Public Health and AMO.



Legalization

- October 17, 2018: the federal *Cannabis Act* legalized cannabis in Canada.
- In Ontario, the Cannabis Statute Law Amendment Act was passed with the intent to protect youth, ensure strict rules against impaired driving and combat the illegal market.



Retail Alternatives

- Currently, cannabis can only be purchased legally through the on-line Ontario Cannabis Store, by those 19 years and older.
- As of April 2019, provincially licensed retail stores will be allowed in areas zoned to permit retail establishments.
- Municipalities are deemed to have opted in unless they explicitly opt out of the provincial private retail model by January 22, 2019.
- 2018 Comprehensive Cannabis Report from Deloitte found the majority of persons who purchase cannabis will do so from a legal source if it is available.



Provincially Licensed Stores

- Stores may not to be located within 150m of any school.
- Store Requirements/Regulations as prescribed by the Ont. Reg. 468/18, including but not limited to:
 - Restricted hours of operation (9am to 11pm)
 - Prevent entry to 19 years of age or older
 - Security/Surveillance systems
 - Training for license holders, retail managers and all employees
 - Store manager must be licensed/holder of a Cannabis Retail Store Manager License
 - Regulation of advertisement and promotion
 - Display of "Provincial Cannabis Authorization Seal"
 - Any other condition as determined by the Registrar




Provincially Licensed Stores

- Municipalities and the public may comment on proposed locations, through the provincial notification process.
- The City is developing a municipal cannabis policy statement to guide its submissions.
- Cannabis will continue to be available on-line and its consumption and possession will continue to be legal in accordance with the applicable legislation.



Provincially Licensed Stores

- On Dec 13, the Provincial Government announced the passing of Ontario Regulation 497/18 of the Cannabis Licence Act, 2018 requiring a phased in approach to issuance of licenses, imposing a lottery system and initially, up to 25 retail stores licenses to be issued on April 1, 2019.
- The distribution of licenses will amount to six (6) retail stores in the Greater Toronto Area, between York, Durham, Peel and Halton Regions.
- 5 retail stores in Toronto.
- Remaining 14 store licenses distributed across Ontario to municipalities with a population greater than 50,000 residents.
- Unclear on how the province plans to issue retail store licenses beyond the initial 25.



Provincial Funding

- Ontario Cannabis Legalization Implementation Fund to be split into three parts:
 - \$15M for all municipalities; distributed on a per household basis.
 - b) \$15M for those who do not opt out (incl. \$5k lump-sum for each who opt out); and
 - \$10M contingency fund, with priority for those who do not opt out.
- Additionally, Province will provide 50% of its share of federal excise duty that exceeds \$100M only to those who have not opted out.
- City of Vaughan's first entitlement is \$124,949 with the equivalent to be provided to York Region.



Places of Use

Cannabis is legal where tobacco is permitted under the Smoke Free Ontario Act.

Where Smoking is Permitted

- Private Residences
- Outdoor Public Places
- Designated Guest Rooms in Hotels, Motels and Inns
- Controlled Areas in Long-Terms
 Care Homes; Retirement Homes
 and Other Provincially-Funded
 Supportive Housing

Where Smoking is Prohibited

- Enclosed Public Spaces and Workplaces
- Schools
- Restaurants, Bars and Patios
- Transit Buses, Terminals and Bus Shelters
- Near Entrance/Exit of Hospitals
- Near Entrances to Municipal Buildings
- Near Playgrounds and Publicly Owned Sports Facilities



Public Consultation

- The City has been keeping the public up to date through its website.
- Staff have been fielding and keeping track of calls, emails and social media.
- Staff conducted a poll through Forum Research to assess public opinion.
- Majority of those polled have concerns about legalization in general, primarily with driving offenses and use in public places.
- 54% opposed to allowing retail stores in Vaughan.



Recreational Sales & Consumption

- Recreational cannabis is legal in Ontario and available for purchase on-line.
- Council's decision is therefore <u>only</u> with respect to the consideration of, acceptance of provincially licensed stores and associated increased funding.
- Provincially licensed stores may discourage purchases from illegal sources.
- Adopting the Province's retail model will maximize opportunities for revenue to offset municipal expenses and costs relating to legalization.



Municipal Responsibility

By-laws under review:

- Vaughan Smoking By-law
- Vaughan Parks By-law
- Property Standards By-law
- Business Licensing By-law (related sections)
- Any other identified by-law



Conclusions

- Greater funding from not opting out will allow the City and York Region to better meet infrastructure (e.g., signage), educational, policing, and by-law demands and related enforcement costs associated with cannabis legalization.
- Staff intend to bring forward a report in Q1, 2019 to ensure the City's By-laws are aligned with the Province's smoking legislation and the broader public interest.
- City Council must make a decision whether or not to opt out.



Next Steps

- By-law & Compliance, Licensing & Permit Service is completing review of impacted regulatory by-laws.
- Depending on Council's decision, staff will either notify the Province of the decision to opt out or develop a public policy to guide response to possible store locations.
- Continue to advocate and engage the Province for the interests, safety and well-being of Vaughan residents.
- Continue to monitor and respond to the evolution and progression of provincial and federal cannabis legislation (e.g. edibles).
