A By-law to dedicate certain lands as part of the public highway.

THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 257 on Plan 65M-4557, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as "Morning Sparrow Drive".
