# ***BY-LAW***

## **BY-LAW NUMBER 164-2018**

### **A By-law to dedicate certain lands as part of the public highway.**

The Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 99 Plan 65M-4558, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Streamside Street”.
2. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being  
Firstly: Block 119 on Plan 65M-4558, registered in the Land Registry Office for the Land Titles Division of York Region (No. 65);  
  
Secondly: Block 239 on Plan 65M-4608, registered in the Land Registry Office for the Land Titles Division of York Region (No.65);  
  
be and they are hereby dedicated as part of public highway known as “First Nations Trail”.
3. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Blocks 101 and 123 on Plan 65M-4558, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Pierre Berton Boulevard”.
4. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 106 Plan 65M-4558, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as “Kleinburg Summit Way”.

5. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 111 Plan 65M-4558, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as "Lacrosse Trail".
6. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 112 on Plan 65M-4558, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as "Laneway V45".
7. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 121 on Plan 65M-4558, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as "Chorus Crescent".
8. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 124 on Plan 65M-4558, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as "John Henry Street".
9. THAT the lands which are situate in the City of Vaughan, in the Regional Municipality of York, being Block 128 on Plan 65M-4558, registered in the Land Registry Office for the Land Titles Division of York Region (No.65); be and they are hereby dedicated as part of public highway known as "Klein Mills Road".
