Purpose

To submit for Council's approval the attached 2019 Schedule of Meetings for City of Vaughan Council and its Standing Committees. Once adopted the Schedule of Meetings will be posted on the City's website and will be the primary means of advising the public of the times and dates of meetings of Council and its Standing Committees.

Report Highlights

- Council and Standing Committee meeting schedule for 2019.
- Monthly meeting cycles have been structured on a two-week cycle subject to variations due to scheduling conflicts.

Recommendations

- That the City Clerk be authorized to amend the schedule by cancelling meetings
 that are not required, or changing the time and/or date of a scheduled meeting,
 subject to posting such amendments on the City's website in accordance with the
 Procedural By-law.

Background

The 2019 Schedule of Meetings is structured on a monthly two-week cycle and takes into consideration statutory holidays, significant faith days, Regional Council and Committee meetings, and major corporate events. The schedule has been prepared in accordance with Procedure By-law 7-2011, as amended.

Every effort has been made to avoid scheduling meetings of Council on significant faith and cultural days that Council and staff are made aware of. Also taken into consideration in preparing the schedule are the FCM Conference scheduled May 30 - June 2, 2019, the AMCTO Conference scheduled for June 10 – 12, 2019, and the AMO Conference scheduled for August 18 – 21, 2019.

Committee and Council meetings have not been scheduled during the months of July and August. If required, a Special Committee or Special Council meeting may be summoned to deal with any pressing issues that may arise by giving 24 hours' notice in accordance with the Procedural By-law.

In keeping with past practice, unless unavoidable due to scheduling variations, the calendar has been structured to avoid the negative aspects of stacking three committee meetings on one day and avoids scheduling meetings on the last full week of the month.

A comprehensive multi-channel public communication plan has been developed to support the budget and to help ensure Vaughan residents, businesses and stakeholders have opportunities to be informed and involved in the budget development process.

Tuesday to accommodate the traditionally heavier

agenda prior to summer hiatus.

September 2019 The cycle of meetings for the month starts the

third week due to internal scheduling conflicts.

October 2019 The cycle begins on Wednesday and the Finance,

Administration and Audit Committee and the Committee of the Whole (Working Session) have been scheduled prior to the Council meetings to

accommodate significant faith days.

November 2019 The cycle has been scheduled for the third week

due to internal scheduling conflicts.
