#### **Purpose**

To present the findings of an investigation by the Integrity Commissioner and Lobbyist Registrar under the City of Vaughan Code of Ethical Conduct (the "Code") relating to the conduct of a Member of Council (the "Respondent") in connection with a complaint alleging violations of rules 1, 7, 9 and 16 of the Code.

# Report Highlights

- The Complaint alleges that the Respondent used their authority for the purpose of commanding or influencing staff with the intent of interfering in staff's duties.
- The Complaint alleges that the Respondent worked closely with a senior Member of staff to undermine staff's recommendation to assume the second phase of the Humberplex Project, a 36.8-hectare single-family development.
- The Complaint investigation findings set out that the Respondent did not violate the Rules of the Code.
- While the Integrity Commissioner and Lobbyist Registrar does not have authority to investigate allegations of wrongdoing on the part of staff, insofar as the Complaint alleges that the Respondent attempted to use their authority for the purpose of influencing a senior staff person to undermine staff's recommendation to assume the second phase of the Humberplex Project, the Integrity Commissioner has submitted in this Report, information received in respect of the staff person named in the Complaint.
- The Integrity Commissioner and Lobbyist Registrar was unable to interview the senior staff person named in the Complaint.

### **Recommendations**

- 1. That no penalty be imposed on the Member insofar as there was no evidence to support that the Member attempted to influence the actions of staff; and
- 2. That the information in respect of the senior staff person presented in the formal Code of Conduct Complaint Investigation Report 101619 be received.

### **Background**

A Formal Complaint was received on October 16, 2019, alleging that the Respondent had contravened Rules 1, 7, 9 and 16 of the Code. In particular, the Complaint alleged that the Respondent worked closely with a senior staff person to undermine the City staff's recommendation to assume the second phase of the Humberplex Project in the City of Vaughan.

In the preliminary classification, it was determined that the Integrity Commissioner and Lobbyist Registrar would be investigating the violations of Rules 1, 7, 9 and 16 of the Code, as alleged in the Complaint. During the course of this investigation, the Integrity Commissioner and Lobbyist Registrar interviewed several witnesses who provided information relevant to the subject matter in the Complaint, including in respect of the behaviour and conduct of the senior staff person generally, and in respect to the subject matter of the Complaint.

Pursuant to the obligations of the Integrity Commissioner and Lobbyist Registrar under s. 10(ii) and 11(ii) of the Complaint Protocol, the Complaint Investigation Report [Attachment 1] sets out the investigative process, decisions on jurisdiction, findings on the allegations related to the Code, analysis, and conclusion.

### **Conclusion**

The Office of the Integrity Commissioner and Lobbyist Registrar recommends that no penalty be imposed on the Member as there was no evidence to support the allegations in the Complaint. While the Office of the Integrity Commissioner and Lobbyist Registrar is not mandated to receive, investigate or make findings in respect of the actions, omissions or decisions of staff, the Integrity Commissioner and Lobbyist Registrar has concluded that information received in respect of the senior staff person named in the Complaint, shall be submitted without comment, to Council for consideration as appropriate.
