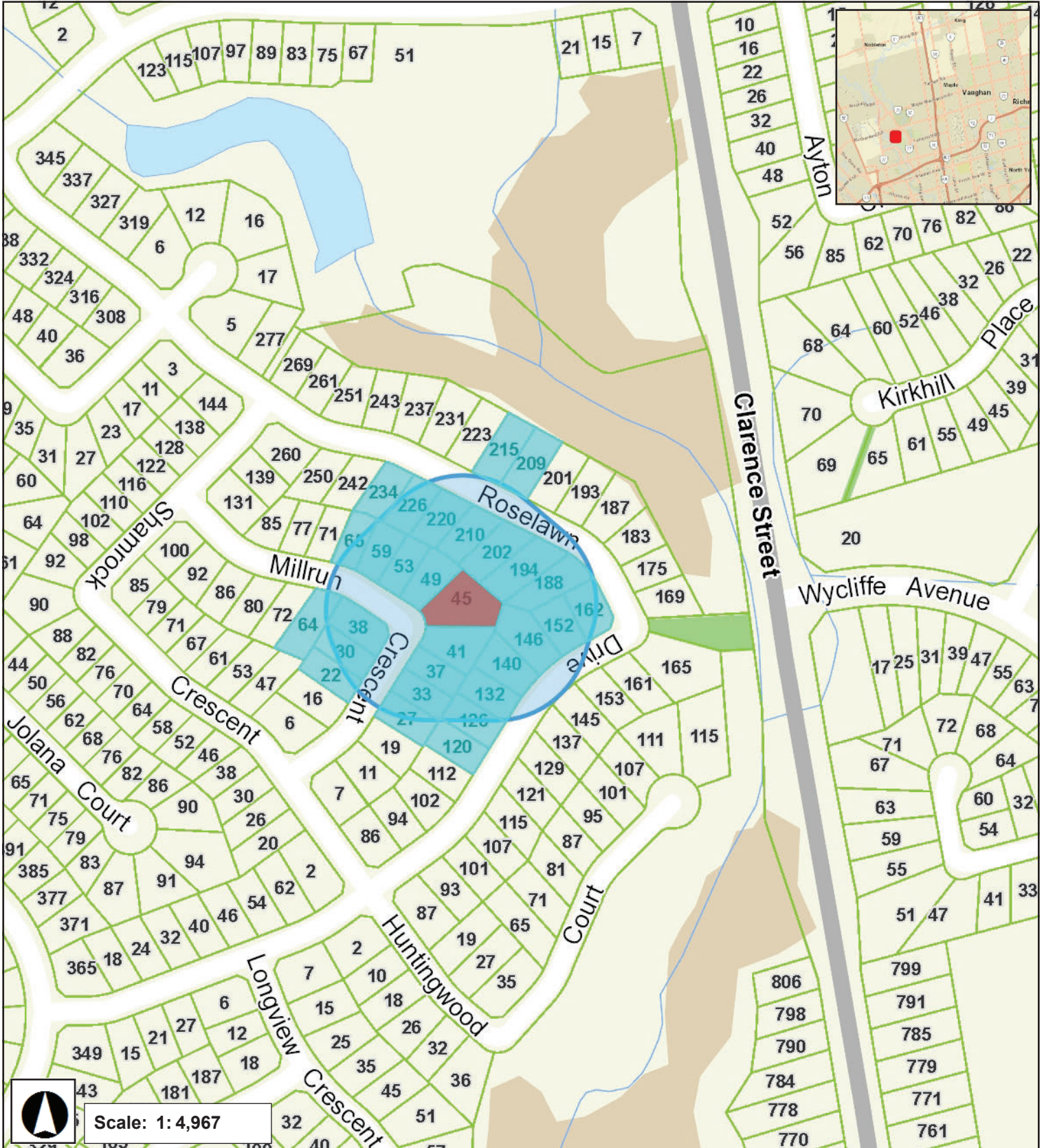

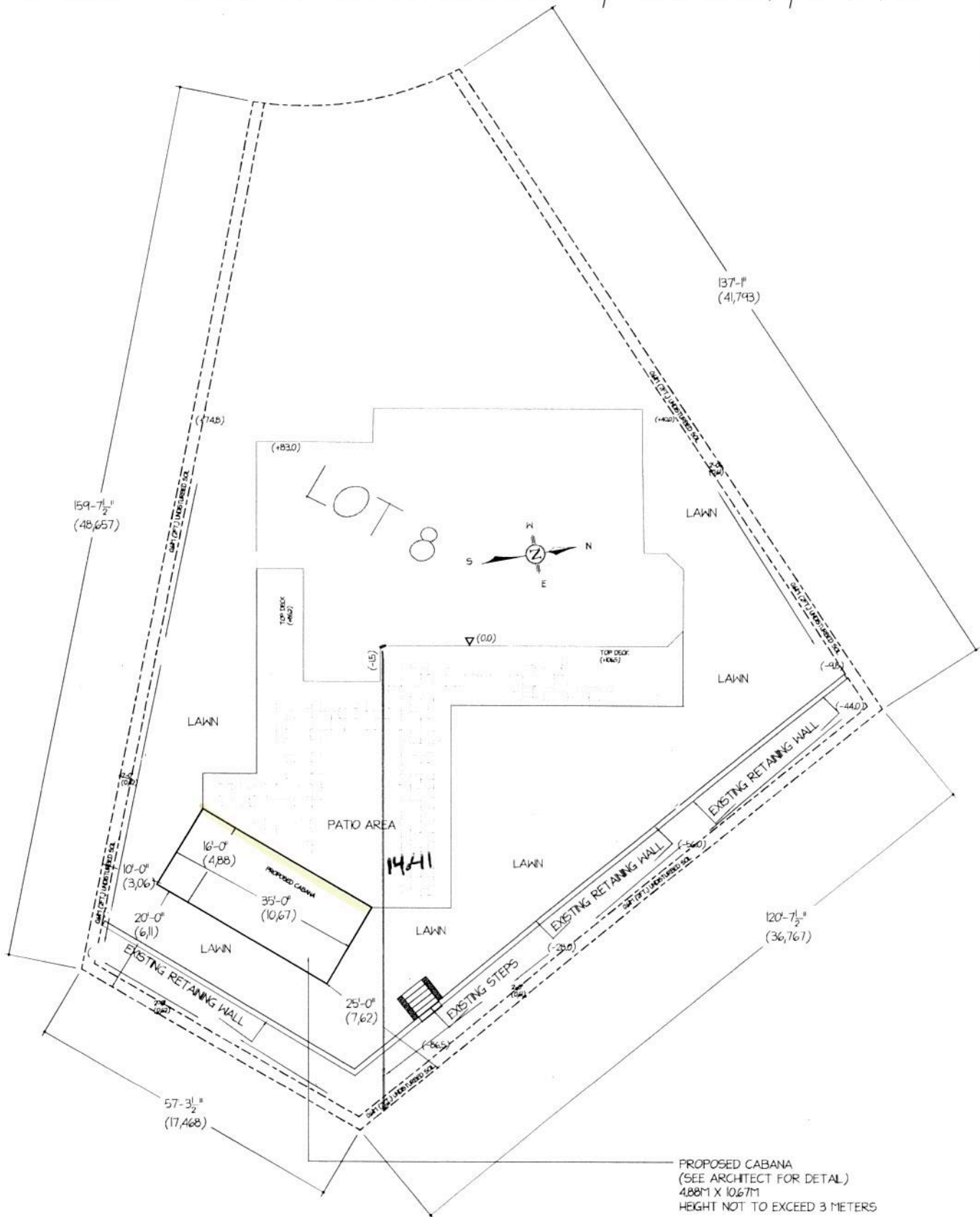

LANDSCAPE DESIGN AT 45 MILLRUN CRESENT, WOODBRIDGE, ONTARIO



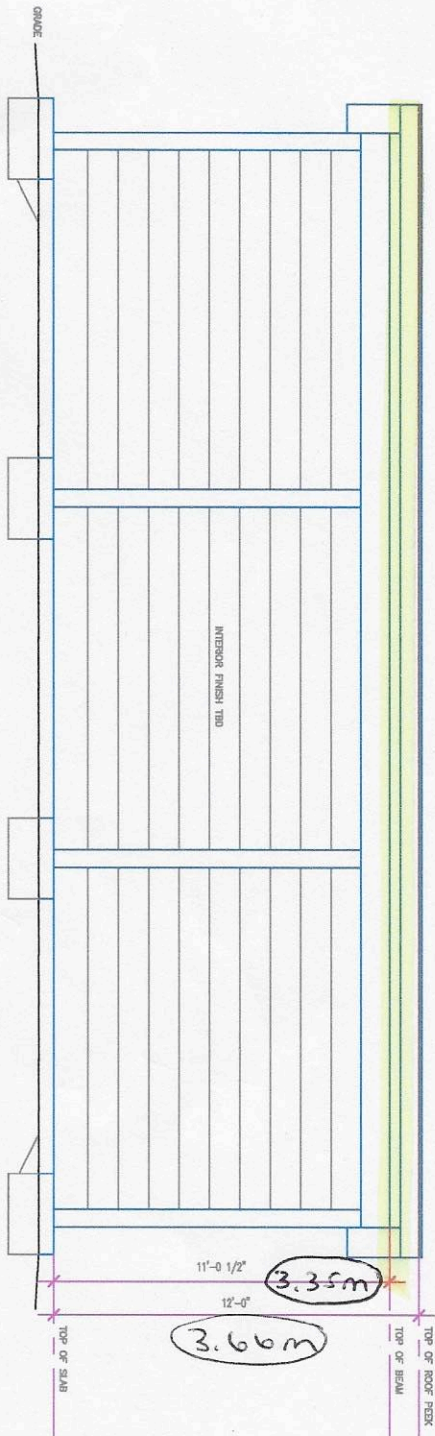

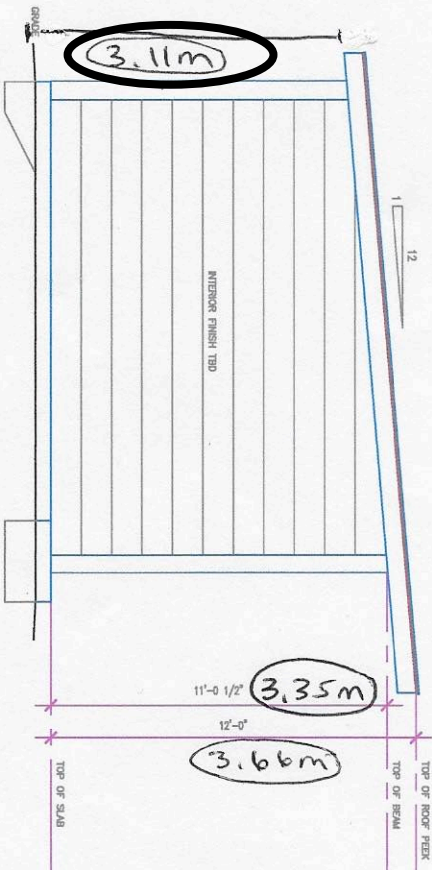

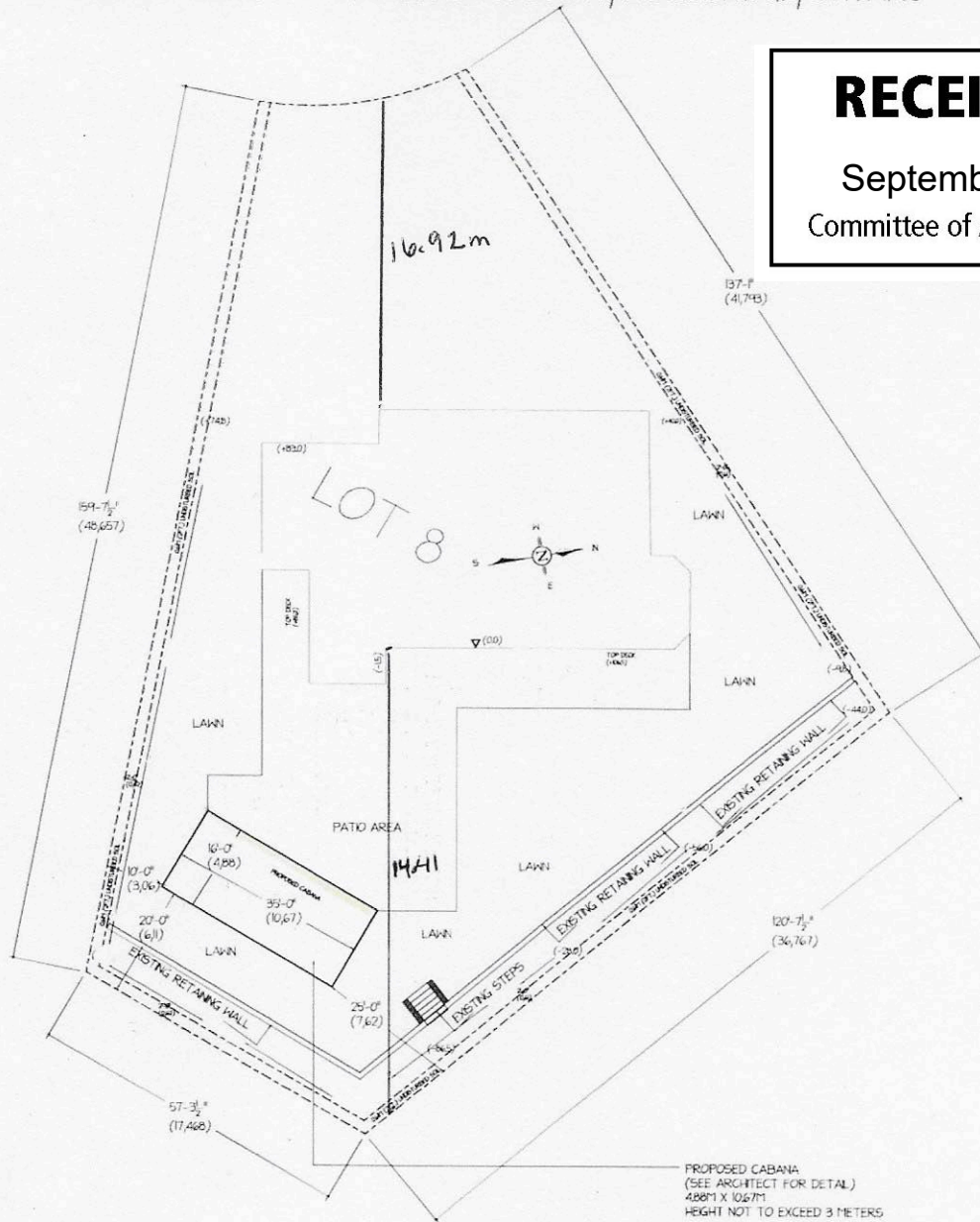
